Prohibits sale of kratom products unless kratom product derives from processor registered with Department of Revenue.

(9:35 am) HB 4014

Extends deadline for submission of final report based on study of system development charges required under section 1, chapter 544, Oregon Laws 2021 (Enrolled House Bill 3040).

- Registration is required to testify by phone or video.
