(1) The Oregon Homeland Security Council is established within the [Office of the 6 Governor] Oregon Department of Emergency Management. The mission of the council is to as-7 sess risks to the safety and security of the State of Oregon with special emphasis on matters related 8 9 to domestic terrorism and other major threats to the people of Oregon, including to critical 10 infrastructure, and to make formal recommendations to the Governor with respect to homeland se-11 curity policy. 12"(2) The council may: 13 "(a) Recommend strategies to the Governor for the effective coordination of information gath-14 ering and dissemination on subjects associated with the mission. 15"(b) Request and receive briefings from state agencies or other entities for development of re-16 ports and recommendations for the Governor on subjects associated with the mission. 17 "(c) Facilitate interagency collaboration, cooperation and coordination on operational issues 18 associated with the mission. "(d) Recommend policies to the Emergency Preparedness Advisory Council on subjects associ-19 20 ated with the mission. 21"(3) The membership of the council consists of: 22"(a) Four members from the Legislative Assembly appointed as follows: "(A) Two members from the Senate appointed by the President of the Senate; and 23 24"(B) Two members from the House of Representatives appointed by the Speaker of the House 25of Representatives; "(b) The Governor; 2627"(c) The Adjutant General; "(d) The Superintendent of State Police; 28"(e) The Director of the Oregon Department of Emergency Management; 29"(f) A representative of the Department of Justice appointed by the Attorney General; 30 31 "(g) The State Resilience Officer; "(h) The State Fire Marshal; 32 "(i) The Director of the Department of Public Safety Standards and Training; 33 "(j) The Director of the Oregon Health Authority; 34 35 "(k) The Director of Transportation;

1 "(L) The State Forester;

2 "(m) The Director of the Department of Corrections;

3 "(n) The Superintendent of State Police;

4 "(o) One member appointed by the Governor to act as a senior policy advisor for emergency 5 operations;

6 "(p) A representative of the Oregon TITAN Fusion Center with the ability to organize and ex-7 plain mission critical information, appointed by the Attorney General; and

8 "(q) Additional members appointed by the [Governor] Director of the Oregon Department of
9 Emergency Management as the [Governor] director may deem necessary.

"(4) Each member appointed to the council under subsection (3) of this section serves at the pleasure of the appointing authority. The membership of a public official ceases upon termination of the office held by the official at the time of appointment to the council.

13 "(5) The Governor is the chairperson of the council.

14 "(6) The Director of the Oregon Department of Emergency Management is the vice chairperson 15 of the council and serves as the chairperson in the absence of the Governor.

"(7) Members of the council are not entitled to compensation under ORS 292.495. The [Governor] director, in the [Governor's] director's discretion, may reimburse members of the council as provided in ORS 292.495 for actual and necessary travel or other expenses incurred in the performance of their duties as members of the council.

20 "(8) A majority of the members of the council constitutes a quorum for the transaction of busi-21 ness.

"(9) Official action by the council requires the approval of a majority of the members of the council.

24 "(10) If there is a vacancy for any cause, the appointing authority shall make an appointment 25 to become immediately effective.

"(11) The council shall meet as needed to carry out the mission of the council, at times and places specified by the call of the chairperson or of a majority of the members of the council.

28 "(12) The council may adopt rules necessary for the operation of the council.

"(13) The council may employ and fix the compensation of such professional assistants and clerical and other employees as the council deems necessary for the effective conduct of its work.

"(14) All agencies of state government, as defined in ORS 174.111, are directed to assist the council in the performance of the duties of the council and, to the extent permitted by laws relating to confidentiality, to furnish information and advice the members of the council consider necessary to perform their duties.

"SECTION 2. Section 148, chapter 539, Oregon Laws 2021, is repealed.

"SECTION 3. ORS 401.532 is amended to read:

"401.532. (1) The Oregon Pre-Disaster Mitigation Fund is established in the State Treasury,
separate and distinct from the General Fund. Moneys received from federal grants for pre-disaster
mitigation efforts shall be deposited into the Oregon Pre-Disaster Mitigation Fund. Moneys in the
fund are continuously appropriated to the [Oregon Military Department] Oregon Department of
Emergency Management to be used to:

45 "(a) Help state agencies and local government units with Federal Emergency Management

1	Agency approved mitigation plans in this state prior to the occurrence of natural disasters; and
2	"(b) Ensure, to the extent possible, that state and local agencies and officials are prepared to
3	respond to threats of human-caused disaster, including but not limited to acts of terrorism.
4	"(2) The Oregon Pre-Disaster Mitigation Fund may receive gifts, grants, bequests, endowments
5	and donations from public and private sources for purposes related to the fund.
6	"(3) The [Oregon Military Department] Oregon Department of Emergency Management shall
7	adopt rules for the disbursement of moneys from the Oregon Pre-Disaster Mitigation Fund.
8	
9	"EMERGENCY INCIDENT TRAINING
10	
11	"SECTION 4. (1) All elected officials in this state, all administrative heads of state
12	agencies and all persons in the state government management service as defined in ORS
13	240.212 shall complete introductory courses offered or approved by the Federal Emergency
14	Management Agency on incident command and the National Incident Management System.
15	"(2) All officials of a local government, as defined in ORS 174.116, who have or could
16	reasonably be expected to have emergency or disaster response responsibility shall complete
17	education on emergency response as recommended by the emergency program manager ap-
18	pointed by the local government under ORS 401.305 or the chief administrative officer of the
19	local government.

21	"EMERGENCY NOTIFICATION SYSTEM PERSONNEL
22	
23	"SECTION 5. The Oregon Department of Emergency Management shall create, fill and
24	utilize at least six positions to provide support for the emergency notification system estab-
25	lished under ORS 401.094.

27	"EMERGENCY RESPONSE EXERCISES
28	
29	" <u>SECTION 6.</u> (1) The Oregon Department of Emergency Management shall develop and
30	administer a program for periodic emergency response exercises as described in this section.
31	"(2) Once per year, the department shall coordinate a multidisciplinary, all-hazards
32	emergency response exercise. The exercise must involve at least 10 percent of the public or
33	private safety agencies in this state. The department shall ensure that each public or private
34	safety agency in this state participates in at least one exercise under this subsection in each
35	10-year period.
36	"(3)(a) At least once per year, each state agency shall conduct an internal exercise that
37	tests at least one element of the state agency's emergency preparedness. Each state agency
38	may determine the nature and focus of the exercise required under this subsection. Once per
39	year, each state agency shall submit a written report to the department describing the na-
40	ture of the exercise, the metrics used by the state agency to analyze the state agency's
41	performance and the outcome of the exercise.
42	"(b) The department shall provide advice and recommendations to state agencies re-
43	garding the requirements of this subsection.
44	"(4)(a) At least once per year, each county shall conduct a tabletop, scenario-based
45	learning exercise related to emergency response. An exercise conducted by a county under

1 this subsection must involve the majority of public or private safety agencies operating in 2 the county. 3 (b) A county need not conduct the exercise required under this subsection during a year 4 in which the county's emergency operations center was partially or fully activated in response to an emergency. 5 6 "(c) The department shall provide advice and recommendations to counties regarding the 7 requirements of this subsection. (5) The department shall consult with the Oregon Homeland Security Council to deter-8 mine priorities for subjects of exercises conducted under this section. 9 "(6) The department may issue grants to local governments to pay for some or all of the 10 11 costs of the exercises required under this section. (7) The department may solicit and accept gifts, grants or donations from public or 12private sources to fund the exercises required under this section. 13"(8) As used in this section: 14 "(a) 'Public or private safety agency' has the meaning given that term in ORS 181A.355. 15"(b) 'State agency' means an agency, entity or official listed in ORS 401.054. 16 17**"OREGON CRITICAL DISASTER PREPAREDNESS STOCKPILE** 18 19 "SECTION 7. (1) The Oregon Homeland Security Council shall establish by rule a program 2021to create the Oregon Critical Disaster Preparedness Stockpile. The council shall consult with 22the Emergency Preparedness Advisory Council and other relevant entities before establishing 23the program. "(2) The purpose of the program is to ensure that Oregonians have access to a robust 24 25stock of supplies and equipment for use in an emergency, including personal protective 26 equipment and raw materials for the sustained manufacture thereof, communicable disease 27testing equipment and all-hazards emergency surge supplies, that can be deployed on a regional basis. 28 29 "(3) The program shall: "(a) Be administered by the council in cooperation with county emergency management 30 agencies and the Oregon Department of Emergency Management or its predecessor office; 3132and (b) Draw upon lessons learned from the COVID-19 pandemic, the 2020 Oregon wildfire 33 season and the work of the Seismic Safety Policy Advisory Commission. 34"SECTION 8. (1) No later than June 30, 2022, the Oregon Homeland Security Council 35 shall, in consultation with the Oregon Health Authority and other relevant state agencies: 36 "(a) Develop a comprehensive list of essential equipment, materials, supplies, distribution 37 channels and manufacturing capabilities necessary to accomplish the purpose of the Oregon 38 Critical Disaster Preparedness Stockpile described in section 7 of this 2022 Act; 39 (b) Determine a statewide standard of availability, sufficient to adequately protect public 40 41 health and safety, for each article of personal protective equipment and each element of communicable disease testing equipment on the list; 4243 "(c) Establish metrics and processes for real-time, transparent reporting of materials, 44 supplies, distribution channels and manufacturing capabilities for each type of equipment or 45 supply on the list that the council deems to be critical in an emergency; and

1 "(d) Collaborate with hospitals, long term care facilities, provider groups and health care 2 organizations to obtain information on the extent to which each entity is able to provide 3 personal protective equipment to personnel who are in contact with patients, including usage 4 rates of personal protective equipment during normal business operations and any additional 5 personal protective equipment each entity may maintain for emergency purposes.

6 "(2) Entities described in subsection (1)(d) of this section shall report the information to 7 the council as expeditiously as practicable in accordance with timelines and parameters es-8 tablished by the council.

9 "(3) The council may subpoena any witnesses or documents necessary to obtain the in-10 formation described in subsection (1)(d) of this section.

"(4) If an entity or witness fails to comply with a subpoena issued by the council under subsection (3) of this section, a court of competent jurisdiction, upon application by the council, shall compel obedience by proceedings for contempt as in the case of disobedience of the requirements of a subpoena issued by the court.

15 "(5) The list required under subsection (1) of this section must, at a minimum, include 16 personal protective equipment and raw materials for the sustained manufacture thereof, 17 communicable disease testing equipment and all-hazards emergency surge supplies.

18 "<u>SECTION 9.</u> The Oregon Homeland Security Council shall provide, no later than Sep-19 tember 30, 2023, to the standing or interim committees of the Legislative Assembly related 20 to emergency preparedness, a report on the progress made and actions taken pursuant to 21 section 8 of this 2022 Act, including an implementation strategy for achieving the robust 22 stock of supplies and equipment described in section 8 of this 2022 Act.

23 "<u>SECTION 10.</u> Following the development of the list by the Oregon Homeland Security 24 Council under section 8 of this 2022 Act, the council shall, in consultation with the Oregon 25 Department of Emergency Management or its predecessor office, the Oregon Business De-26 velopment Department, the Oregon Health Authority and the Oregon Department of Ad-27 ministrative Services, adopt rules to implement and achieve as expeditiously as practicable 28 the program and objectives described in section 7 of this 2022 Act, including, without limi-29 tation:

"(1) Establishment of a rotation schedule for supplies, equipment and materials in the
 Oregon Critical Disaster Preparedness Stockpile; and

"(2) Establishment of quality standards for elements of the Oregon Critical Disaster
 Preparedness Stockpile, utilizing guidance from the Centers for Disease Control and Pre vention and other public health organizations.

³⁵ "<u>SECTION 11.</u> (1) Following the development of the list by the Oregon Homeland Security

The mission of the council is to facilitate policy recommendations for catastrophic 42disaster preparedness, mitigation and response and recovery planning, procedures and protocols with 43 44 special emphasis on outreach to representatives of designated state and federal emergency support 45 functions.

11	the council in the performance of the duties of the council and, to the extent permitted by laws re-
12	lating to confidentiality, to furnish information and advice the members of the council consider
13	necessary to perform their duties.

15	"COMMERCIAL DRIVER LICENSES

17	" <u>SECTION 14.</u> Section 15 of this 2022 Act is added to and made a part of the Oregon
18	Vehicle Code.
19	" <u>SECTION 15.</u> (1) The Department of Transportation, in accordance with a concurrent
20	federal waiver, may modify or waive the requirements found in ORS 807.040, 807.060, 807.070,
21	807.100, 807.120, 807.173 or 807.285 when issuing, renewing or replacing a commercial driver
22	license or commercial learner driver permit.

38	"SECTION 17. Sections 5 and 6 of this 2022 Act and the amendments to ORS 401.109 and
39	401.532 by sections 1 and 3 of this 2022 Act become operative on July 1, 2022.

43	"SECTION 18. The unit captions used in this 2022 Act are provided only for the conven-
44	ience of the reader and do not become part of the statutory law of this state or express any
45	legislative intent in the enactment of this 2022 Act.

3	" <u>SECTION 19.</u> This 2022 Act being necessary for the immediate preservation of the public
4	peace, health and safety, an emergency is declared to exist, and this 2022 Act takes effect
5	on its passage.".
