


2023-25 Legislatively Adopted State Budget

- \$121.3 billion total funds
- \$33.5 billion General Fund and Lottery Funds
- General/Lottery Fund spending increased 17.2% over the 2021-23 legislatively approved budget
- General/Lottery Fund spending in the education program area increased 9.1% over the 2021-23 legislatively approved budget.

2023-25 Legislatively Adopted State Budget


General Fund and Lottery Funds only \$ in millions



General & Lottery Fund spending by program area

- In the recent past, the State School Fund has been the largest single expenditure in the state's General/Lottery Fund budget. In 2023-25, the Human Services program area becomes the largest state General/Lottery Fund expenditure at 33.7%.
- The total Education program area budget for 2023-25 is still the largest state General/Lottery expense, however, at 41.1% of the state General/Lottery Fund budget.

Percentage of General and Lottery Fund Spending by Program Area




2023-25 Education Program Area Budget

- The State School Fund represents nearly half of all state spending on education.
- The Department of Early Learning and Care is a new state agency as of July 1, 2023.
- The Department of Education's budget includes \$2.9 billion of spending from the Fund for Student Success. (see following slides)
- Total higher education budget of \$4.1 billion. (see following slides)




Education Program Area Budget by Fund Type

- The Fund for Student Success contributes significantly to K-12 education spending. It is 13% of total education program area spending, but 17.9% of K-12 spending.
- Nonlimited Federal Funds support school nutrition programs.
- Higher education programs make up 23% of the General & Lottery
 Funds total for the education program area budget in 2023-25.


K-12 School Formula Resources

- State School Fund "formula resources" include both state revenues that make up the State School Fund and local taxes and revenues.
- Local taxes and revenues are not included in the state budget.
- Formula resources total \$15.3
 billion for the 2023-25 biennium, a \$1.4 billion increase over the 2021-23 legislatively approved budget.
- Total formula resources are 66.5% state and 33.5% local.

\$15.3 billion total funds \$ in millions




Change in formula resources

- Total formula resources in the 2021-23 biennium were \$14.012 billion.
- 2023-25 legislatively adopted formula resources of \$15.344 billion represent a 9.5% increase over last biennium.

Change in Formula Resources


2021-23 legislatively approved to 2023-25 legislatively adopted \$ in millions



School Formula Resources Over Time

- From 2003-05 through 2013-15, total formula resources grew, on average, 6.8% on a biennium-overbiennium basis.
 - Recession during the 2009-11 biennium resulted in a 2.3% reduction from the 2007-09 biennium
- From 2013-15 through 2023-25, total formula resources grew, on average, 8.9% on a biennium-overbiennium basis.
 - Total formula resources for the 2023-25 biennium increased by 9.5% from 2021-23.

School Funding Formula Resources 2003-05 to 2023-25




Average Daily Membership and Additional Weights

- The State School Fund is distributed to school districts on a per-pupil basis.
- For purposes of distributing State School Fund formula resources, additional weights are applied for students in certain categories.
- Student categories and weights are:
 - Individual Education Program 1.00
 - English as a second language 0.50
 - Pregnant and Parenting teen 1.00
 - Students in poverty households 0.25
 - Students in foster homes 0.25
 - Students in Youth Corrections 2.00
 - Students in Juvenile Detention 1.50

Number of Students (ADMr) with Additional Weights (ADMw) 2003-04 through 2023-24*





Change in weights over time

- The weight for students on Individual Education Programs is capped at 11% of a district's ADMr, unless reviewed and approved by ODE.
- The number of pregnant and parenting teen weights has dropped from 1,398 in 2003-04 to 278 in 2023-24.
- Weights do not increase the total amount of funds available to school districts, but rather redistribute formula resources between districts.

Statewide Uses of State School Fund resources ("carve-outs")

- Certain programs are funded at the state level through set-asides in the State School Fund.
- Carve-outs can change from one biennia to the next.
 - There are two new carve-outs totaling \$7.3 million in 2023-25: one for a School Safety and Emergency Management program, and one for the Oregon Youth Challenge Program.
 - Three carve-outs totaling \$7.5
 million were eliminated in 2023: a
 free lunch subsidy program, a
 facilities grant program, and a virtual
 school districts program.

Fund for Student Success

- 2023-25 legislatively adopted budget of \$2.927 billion
 - \$1.087 billion Student Investment Account
 - \$595.8 million Statewide
 Education Initiatives Account
 - \$542.6 million Early Learning Account
 - \$702 million transfer into State
 School Fund
- Includes new investments in early literacy (\$114.3 million), hunger free schools (\$17 million), and a \$194.9 million (21.8%) increase in the Student Investment Account.

Corporate Activities Tax

- Collected on gross receipts in Oregon of >\$1M
- Portion to Department of Revenue for administration

Fund for Student Success

- •Separate and distinct from the General Fund
- Not subject to kicker
- Transfer to State School Fund (ORS 327.001(4)(B))
- Transfer to High-Cost Disabilities Account (\$40M)

Three accounts

- Student Investment Account (50%)
- Statewide Education Initiatives Account (<=30%)
- Early Childhood Account (>=20%)

Other K-12 education spending

- K-12 grant-in-aid programs total \$4.9 billion and support a broad array of targeted education programs
- New investments in 2023-25 include:
 - \$114.3 million for early literacy programs
 - \$18.5 million for early intervention/early childhood special education programs
 - \$17 million for the Hunger-Free Schools program
 - \$10 million General Fund for educator apprenticeship and mentorship grants



Other K-12 programs by fund type

- "Other K-12 programs" include agency operations, grant-in-aid programs (including those in the Fund for Student Success), the Educator Advancement Council, and youth development programs.
- The 2021-23 budget included:
 - Federal pandemic relief funding of \$1,231.3 million
 - The Early Learning Division, now its own state agency
 - State-funded pandemic relief programs, including summer learning (\$150 million GF) and teacher recruitment/retention programs (\$100 million GF)


Early Childhood Education

Department of Early Learning and Care

- A new agency as of July 1, 2023, with a 2023-25 legislatively adopted budget of \$1.339 billion.
- Federal pandemic relief funding is one-time in the 2023-25 biennium, and will leave a budget gap in 2025-27 for the following programs:
 - Office of Child Care, \$15.5 million
 - Child Care Supports, \$26.2 million
 - PDG grant, \$12.7 million
 - ERDC subsidies, \$96.6 million, or 27.4% of the 2023-25 ERDC subsidies budget

2023-25 Legislatively Adopted Budget by Fund Type \$\text{S in millions}\$




Early Learning Program budgets 2023-25

- The Department of Early Learning and Care (DELC) includes most early childhood programs from the Department of Education and the Employment Related Day Care program from the Department of Human Services.
 - The Early Intervention/Early Childhood Special Education program is still operated by the Department of Education.
- Child care subsidy programs and provider payments make up more than 75% of the agency's budget.





^{*}The 2023-25 budget also includes a special purpose appropriation to the Emergency Board in the amount of \$18,735,518 General Fund for potential HECC grants to Portland State University and Oregon's Technical Regional Universities (TRUs) to assist these institutions with long-term financial sustainability, based on the proof-of-concept efforts funded with this \$6,164,482 in the HECC budget.



Public University State Programs

- Provides General Fund support for a variety of institutions, centers, and programs operated by public universities that address economic development, natural resource, and other public policy issues.
- Many programs have an industryspecific focus, and match state support with funds from the private sector and/or other sources.



Community College Sources of Revenue


- State Support includes all state funding for the Community Colleges Support Fund, debt service, and other state grants.
- Local revenues are property taxes, and are not included in the state budget.
- The Tuition/Fees amount is net of remissions and waivers.
- Complete revenue data for the 2021-23 biennium will be available after February 2024.

Community Colleges Sources of Revenue Millions of Dollars




State Support for Community Colleges

- State support for community colleges has grown by 71% from the 2013-15 biennium
 - \$466.9 million in 2021-23
 - \$800.3 million in 2023-25




Community College Enrollment


- Enrollment in community colleges, measured in both headcount and student FTE, has fallen by about 40% since 2012
- Declining enrollment is a continuing trend
 - Declining birth rates
 - Declining numbers of high school graduates, both in Oregon and in states from which Oregon universities recruit
 - Skepticism of the price and value of a college degree
 - High costs of tuition and fees

Resident & Non Resident Public University Students*




Average Public University Tuition & Fees

- Graph to the right and on the next slide shows change in inflation factors applied
 - Prior to 2021-22, inflation was applied using the Consumer Price Index (CPI)
 - Starting in 2021-22, HECC uses the Higher Education Cost Adjustment (HECA) to model inflation
- HECA was developed by the State Higher Education Executive Officers (SHEEO) Association as an alternative to the CPI
 - Accounts for different cost drivers specific to the higher education cost environment

Community College Tuition and Fees Increases




Oregon Opportunity Grant

- Grant awards are available to eligible students attending Oregon colleges and universities for up to four years of full-time enrollment
- Students must reapply each year by submitting a Free Application for Federal Student Aid (FAFSA) or an Oregon Student Aid application (ORSAA)
- Many variables affect funding level and availability, leading to uncertainty for students
