## **Emergency Homelessness Response**

Rehousing overview



Homelessness is, at its root, a housing problem. An effective and compassionate response to homelessness at the systems level must devote significant attention and resources to securing housing placements for those living outside and supporting those households to maintain their housing through several types of assistance. By providing a range of critical supports, rapid rehousing programs offer quick transitions into secure, stable housing and address underlying factors contributing to the experience of homelessness.





House Bill 5019 allocated a total of \$85.2 million for both shelter and rehousing efforts with goals of rehousing 1,200 households by January 10, 2024 in the regions designated by EO 23-02 and \$26.135 million to rehouse 450 households within the Rural Oregon Continuum of Care (ROCC) by June 30, 2025.
