Office of Developmental Disabilities Services (ODDS): History

- Strong foundation of home and communitybased services that allowed for successful deinstitutionalization
- Medicaid funding authorities that ensure services for all eligible individuals according to the level of need
- Employment First state promoting competitive integrated employment for people with intellectual and developmental disabilities (I/DD)
- Serve all eligible individuals regardless of immigration status



ORS 427: Need for civil commitments

For the purposes of ORS 427.235 to 427.290, a person with an intellectual disability is in need of commitment for residential care, treatment and training if the person:

- Has an Intellectual Disability and
- Is determined eligible for developmental disability services under ORS427.104; and
- Is dangerous to self or others; or
- Is unable to provide for the person's basic personal needs and is not receiving care necessary for the health, safety or habilitation of the person.

Departmental requirements

When a person is determined:

- 1. To be a danger to themselves or others and
- 2. Has an intellectual disability confirmed with an evaluation less than 12 months old and
- 3. Is eligible for ODDS services in Oregon with an Intellectual Disability and
- 4. The court has ordered a civil commitment.

Then the Department is delegated responsibility: ORS 427.300 — The Department may delegate responsibility of the person's assignment to a suitable facility to either a CDDP or support services brokerage, at the Department's discretion.


- When a person enrolled in a brokerage is committed, CDDP and brokerage coordinate facility assignments and consider a variety of settings, including residential settings, to select an appropriate setting to maintain the person's safety, health and training needs.
- For the person who is committed, ORS 427.306 requires the least restrictive environment suitable for the emotional and physical needs and protection of others.

Recent changes: Oregon House Bill 3234

HB 3234 passed in 2023, which declares an emergency, effective on its passing, and revised ORS 427.235 through 427.290, Civil Commitments, with these changes:

- 1. Prohibiting the commitment of children with intellectual disabilities without consent of parent or legal guardian
- 2. As a condition of commitments, a person must be determined to have an intellectual disability and determined eligible for developmental disability services through Oregon Department of Human Services
- 3. After the first commitment, removes the requirement for a new diagnostic evaluation within the past 12 months for re-commitments
- 4. Adds brokerages as an entity that may be responsible for assignment of the person to suitable facilities or transfers between facilities

Demographics: Civil commitments of Oregonians with I/DD



Note: In 2023, there have been 19 active civil commitments.

- 13 completed in 2023
- orders or re-commitments

Demographics: Persons committed to ODDS in 2023

All but one person have confirmed mental health diagnoses

• Schizophrenia, mood disorders, bipolar disorder, risk of suicide, etc.

Geographic location

- Four counties: Lane, Linn, Marion and Multnomah
- Majority in Marion County

Gender

- 42% female
- 58% male

Residential location

42% in the Stabilization and Crisis Unit managed by ODDS

Conflict: Current service system requirements

Medicaid authorities that fund Oregon's home- and community-based system (HCBS) require:

- Person or their guardian must choose to access services.
- Person or their guardian has a choice of setting and services.
- Protection of person's rights and freedoms.

Additionally, Oregon no longer has institutions for people with I/DD.

- All services are home and community based and voluntary.
- Services are intended to fully integrate the individual into their community

Conflict: Civil commitments and the current system

Civil commitments conflict with the current system's requirements.

- Don't assign a guardian, but instead direct ODDS or local CDDP director to assign a facility and an attendant to confine and detain the individual.
- Don't prevent a person from leaving services
- Don't guarantee a person who does leave will be returned to a service setting.
- No requirement for law enforcement to respond.
- Providers can refuse to serve a person, regardless of whether they are involuntarily committed.
- Don't help someone access necessary mental health and crisis supports that could help individuals be served successfully in the community.
- Remove civil rights and are a form of institutionalization: People involuntarily committed may not have been charged with any crimes and still have their rights taken away.

Other options for consideration

Guardianship is a more comprehensive way to help a person receive and remain in services.

- Additional guardianship options are currently limited in our system when guardianship is needed due to a person's risk to themselves or others.
- Support for expedited access or support for families to acquire guardianship is limited for when it is needed due to a person's risk to themselves or others.

Other alternatives

- Power of attorney
- Protective order
- Commitments through the mental health system (426 commitments) will remain an option for persons with mental health diagnoses.


