# **National Snapshot:**

Total number experiencing homelessness: 582,462

Number of Veterans experiencing homelessness: 33,129 (decrease of 11% since January '20).

Of this total: 19,565 Veterans experiencing sheltered homelessness.

13,564 Veterans experiencing unsheltered homelessness.

- Estimated number of Veterans experiencing homelessness in America has declined by 55.3% since
   2010.
- Veterans are 50% more likely to become homeless than other Americans due to poverty, lack of support networks, and dismal living conditions in overcrowded or substandard housing. About 1.5 million veterans are considered at-risk of homelessness.

## SUPPORTIVE SERVICES FOR VETERAN FAMILIES (SSVF) PROGRAM

**SSVF** is designed to rapidly rehouse and provide guidance and case management services to Veteran families (defined as a single Veteran or a family in which the head of household or the spouse of the head of household is a Veteran) who are homeless or at imminent risk of becoming homeless. VA grants funds to private nonprofit organizations and consumer cooperatives to help Veteran families access a full range of community benefits designed to prevent homelessness. Through SSVF, Veterans can obtain VA and other benefits that may include health care, daily living services, financial planning services, transportation, legal services, childcare, and housing counseling. Time-limited payments to landlords, utility companies, moving companies, and licensed childcare providers may also be provided to help Veterans stay in or acquire permanent housing. (VA)

- Approximately \$418 million in grants were awarded to 261 nonprofit organizations.
- 105,170 Veterans and family members served by SSVF in FY 2022.
- Of those Veterans discharged from the SSVF program, 72% obtained permanent housing.
- Since 2010, the U.S. Department of Veterans Affairs (VA) has helped nearly 986,000 Veterans
  and their families avoid or exit homelessness.

## **Transition Projects, Inc., SSVF:**

Our SSVF program serves Veterans experiencing literal homelessness in the Portland Metro area to obtain permanent housing in the shortest amount of time, while providing a full range of community benefits and supportive services needed to maintain housing. We work with Veterans to formulate a sustainable plan for income, identify needs, and refer to our internal supportive services team, as well as community resources and supports. We also serve Veterans at imminent risk of homelessness (within 30 days), whether facing eviction or other challenges to housing stability, as funding allows. We are the largest holder of Veterans' grants (SSVF, GPD), from the VA, in the Northwest.

#### Who Do We Serve?

Veterans and Veteran families in which the head of household, or the spouse of the head of household, is a Veteran.

**Veteran** is defined as a person who served in the active military, naval, or air service, regardless of length of service, and who was discharged or released there from. Veteran excludes a person who received a dishonorable discharge from the Armed Forces or was discharged or dismissed from the Armed Forces by reason of the sentence of a general court-martial. SSVF also serves Veterans who served in the Guard/Reserves if activated via Title 10.

## **Other Eligibility Criteria**

- Veteran/Vet Family gross household income must be below 80% AMI
- Veteran/Vet Family must be experiencing literal homelessness, or at imminent risk of homelessness within 30 days.
