Oregon's Civil Commitment Statutes

- ORS Chapter 426 (mental illness)
- ORS Chapter 427 (intellectual disability)

Qualifying mental illness	Oregon Health Authority	Treatment
"Extremely dangerous" because of a qualifying mental disorder	Oregon State Hospital; Psychiatric Security Review Board	Custody, care, and treatment
Intellectual disabilities	Oregon Department of Human Services	Care, treatment, or training

Civil Commitment is Different than Aid & Assist


Civil Commitment

- Person with a mental illness
 - Dangerous to self or others
 - Unable to provide for basic personal needs
- In need of treatment
- Civil proceeding for commitment up to 180 days or recertification



Aid & Assist


- Person with criminal charges
- Unfit to proceed in case due to qualifying mental disorder
- Court-ordered treatment either in the community or OSH to restore defendant's fitness to proceed in case

Includes all civil commitment cases for mental illness, extremely dangerous, and intellectual disability

Commitment to Change Workgroup Overview



- A multidisciplinary workgroup formed by former Chief Justice Martha Walters in August 2022 at the recommendation of OJD's Behavioral Health Advisory Committee
- Charged to undertake a comprehensive review of Oregon's civil commitment laws and offer recommendations for legislative reform in 2025
- Committed to inclusive and transparent processes that incorporate input from all interested stakeholders

CTC Workgroup Building on Prior Efforts

Reforming Oregon's civil commitment statutes has been an area of legislative interest for several years

- Legislative Workgroup to Decriminalize Mental Illness, co-chaired by Senator Floyd Prozanski and Judge Pat Wolke (Josephine County Circuit Court), met from 2017-2021 with a focus on changes to ORS Chapter 426
- HB 3234 (2023) amended ORS Chapter 427, and Senator Gelser Blouin has a current workgroup to consider further changes



CTC Workgroup

Issues at each step of the current civil commitment process and across multiple steps PROCESS



Maximizing Workgroup Input at the Table and Beyond

We recognize that an effective workgroup requires:

- limited size to allow for meaningful exchange of ideas
- balance of stakeholder interests through representative membership
- meaningful opportunities for all interested persons to provide input
- recommendations that integrate input from workgroup and interested persons



The CTC Workgroup established the following processes to maximize input by all interested persons:

- All workgroup meetings are held online and open to public for observation
- Each member must create an email distribution group to share information and receive feedback from interested persons in their entities, organizations, and constituencies
- Every month, each workgroup member must send the most recent workgroup minutes and a survey link to their distribution lists for input on topics that will be discussed at the upcoming meeting
- Staff compiles survey responses and reports the results for consideration in the workgroup meeting discussions (typically >100 survey responses per meeting)



CTC Workgroup **Process**

- Neutral facilitator (Masters level clinician, Ed.D. candidate, former director of Oregon Center on Behavioral Health and Justice Integration)
- Full-time workgroup analyst (Ph.D. candidate, civil commitment researcher)

• Iterative meeting process to ensure all members gain a core knowledge of civil commitment system

- Overviews, statistics, constituent survey responses, and workgroup discussions on each step in current civil commitment process
- Monthly reading assignments and handouts to provide national context and awareness of academic research on civil commitment
- PowerPoints that guide each meeting through directed questions that keep discussions moving towards the development of recommendations
- Regular opportunities to offer ideas for system improvement verbally or in writing, during or between meetings, big or small
