SUMMARY

Digest: The Act would require the Director of OED to conduct periodic assessments of the Paid Family and Medical Leave Insurance Fund. The Act would allow the director to take actions if the director found the fund to be insolvent. The Act would take effect when the Governor signs it. (Flesch Readability Score: 60.7).

Requires the Director of the Employment Department to conduct periodic assessments to determine the solvency of the Paid Family and Medical Leave Insurance Fund. Specifies the actions that the director may take to restore solvency if the director determines that the fund is, or may be, insolvent.

Requires the Director of the Employment Department to include in the department's biennial reports to the Legislative Assembly, a summary of the periodic assessments conducted by the director and a summary of any actions taken by the director to restore solvency.

Declares an emergency, effective on passage.

6 <u>SECTION 1.</u> Section 2 of this 2024 Act is added to and made a part

7 of ORS chapter 657B.

8 **SECTION 2.** (1) As used this section:

9 (a) "Family leave for parental bonding" means the family leave de-

10 scribed under ORS 657B.010 (18)(a)(A).

11 (b) "Grant" means a grant described under ORS 657B.200.

12 (c) "Projected expenses" means benefits anticipated to be claimed

13 by covered individuals under ORS 657B.090, anticipated grant awards,

any anticipated costs and expenses associated with processing payments of the benefits and grant awards and any other expenses anticipated to be incurred by the Employment Department in carrying out the provisions of this chapter.

5 (d) "Solvency of the fund" and "solvent" means that the cumulative 6 amount of contributions collected under the provisions of this chapter 7 and any other moneys deposited in the fund are sufficient to pay, in 8 full and in a timely manner, not less than six months of projected 9 expenses.

10 (2) The Director of the Employment Department shall periodically 11 assess the Paid Family and Medical Leave Insurance Fund established 12 under ORS 657B.430 to make determinations regarding the solvency 13 of the fund. The director shall use actuarial calculations in making 14 such determinations and may consider any relevant information in-15 cluding, but not limited to:

(a) The total cost of administrative expenses incurred by the de partment during the six-month period immediately preceding a peri odic assessment of the fund.

(b) The number of grant applications received by the department in
 the calendar year immediately preceding a periodic assessment of the
 fund.

(c) The total grants awarded in the calendar year immediately pre ceding a periodic assessment of the fund.

(d) The average amount of weekly benefits paid in the calendar year
immediately preceding a periodic assessment of the fund.

(3) Notwithstanding any other provision under this chapter, if,
pursuant to subsection (2) of this section, the director determines that
the fund is or may be insolvent, the director may take any of the following actions to maintain or restore the solvency of the fund:

31 (a) Adjust the maximum weekly benefit amount provided under

ORS 657B.050 (2)(a) so that the maximum weekly benefit amount is less
 than 120 percent but not less than 100 percent of the average weekly
 wage.

(b) Adjust the weekly benefit amount available to eligible employees
under ORS 657B.050 (1)(b) such that the employee's weekly benefit
amount is the sum of:

7 (A) 65 percent of the average weekly wage; and

(B) Not less than 40 percent of the employee's average weekly wage
that is greater than 65 percent of the average weekly wage.

10 (4) Notwithstanding any other provision under this chapter:

(a) Except as provided in paragraph (b) of this subsection, if, after 11 12taking both of the actions authorized under subsection (3)(a) and (b) of this section, it is apparent to the director that the fund is or may 13 be insolvent, the director may reduce the number of weeks that would 14 otherwise be available to a covered individual under ORS 657B.020 (1) 15to reflect that a covered individual may qualify for 10 weeks of family 16 and medical leave insurance benefits per benefit year for family leave, 17 medical leave and safe leave taken individually or in any combination. 18 (b) Nothing in this subsection authorizes the director to reduce the 19 number of weeks that would otherwise be available to a covered indi-20vidual under ORS 657B.020 (1) for family leave for parental bonding 21taken individually or in combination with: 22

23 (A) Other family leave, medical leave or safe leave; and

(B) The leave for which a covered individual may qualify under ORS
657B.020 (3).

(5)(a) Whenever an adjustment to benefits occurs as a result of any
action taken by the director pursuant to subsections (3) and (4) of this
section, the adjustment shall remain effective for not more than five
calendar years from the date on which the action was taken.

30 (b) The director shall discontinue the use of this section to deter-31 mine appropriate benefits and shall resume determining benefits in

1 accordance with ORS 657B.020 and 657B.050 not later than whichever of the following first occurs: $\mathbf{2}$

(A) Upon the director's determination that resuming determi-3 nations in accordance with the provisions of those sections will not 4 cause volatility in the fund or with respect to the administration of 5the family and medical leave insurance program. 6

(B) The date described under paragraph (a) of this subsection.

(6) Any action taken by the director under this section shall apply 8 to benefits to be claimed in benefit years beginning on or after the 9 first day of the first calendar quarter following the date on which the 10 action was taken. 11

12(7) The director shall provide at least 30 days' advance notice to the public of any changes to benefits resulting from any action taken by 13 the director under this section, including the effective date of such 14 changes. The director shall give notice to the public by posting the 1516 information on the website maintained by the department.

SECTION 3. Section 51, chapter 700, Oregon Laws 2019, is amended to 17read: 18

Sec. 51. (1)(a) The Director of the Employment Department shall submit 19 to the interim committees of the Legislative Assembly related to workforce 2021or business and labor, in the manner provided in ORS 192.245, reports summarizing the Employment Department's progress toward implementing the 22family and medical leave insurance program described in ORS chapter 657B. 23(b) The director shall submit the first report not later than February 15, 242020, and a second report not later than September 1, 2022. 25

(2) Beginning on July 1, 2024, and once during each of the following 26[three] five consecutive biennia, the director shall, to the extent that the 27director has acquired the information, submit to the interim committees of 28the Legislative Assembly related to workforce or business and labor, in the 29manner provided in ORS 192.245, a report that includes: 30

(a) The total number of claims submitted under ORS 657B.090. 31

7 (e) The amount of contributions collected under ORS 657B.150.

8 (f) The number of applications for plan approval submitted under ORS 9 657B.210, including the number of plans approved and the costs the depart-10 ment incurred in reviewing such applications.

(g) The number of applications received by the department for employerassistance and the total amounts awarded in grants under ORS 657B.200.

(h) A summary of any periodic assessments conducted by the director pursuant to section 2 of this 2024 Act to determine the solvency
of the Paid Family and Medical Leave Insurance Fund, including a
summary of the information upon which the solvency determination
was based.

(i) A summary of any action that was taken by the director under
 section 2 of this 2024 Act to restore the solvency of the fund and the
 resulting outcomes of such action.

[(*h*)] (3) The director shall include in the reports described in this subsection any recommendations made by the advisory committee under ORS 657B.380.

24 <u>SECTION 4.</u> This 2024 Act being necessary for the immediate pres-25 ervation of the public peace, health and safety, an emergency is de-26 clared to exist, and this 2024 Act takes effect on its passage.
