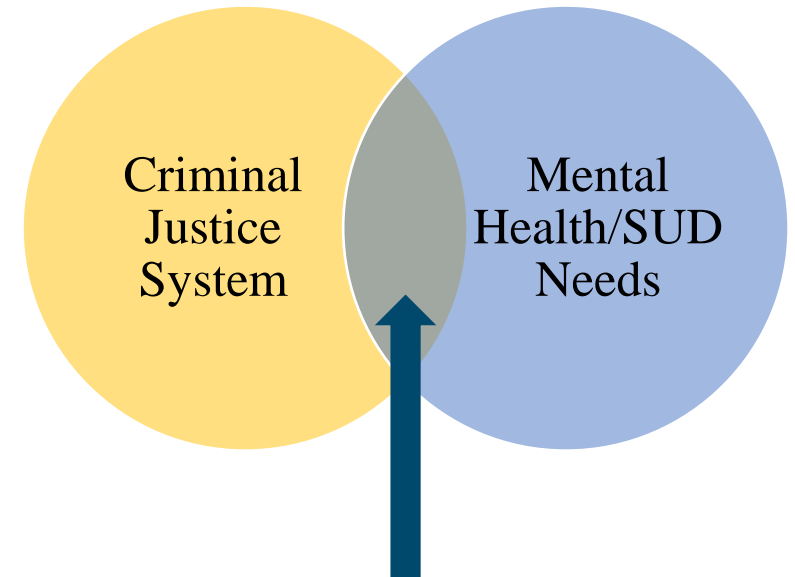
# IMPACTS Grant Program

## INTRODUCTION & BACKGROUND

- IMPACTS was created via Senate Bill 973 in 2019:

*The Improving People's Access to Community-based Treatment, Supports, and Services Program is established in recognition of the shortage of comprehensive community supports and services for individuals with mental health or substance use disorders, leading to their involvement with the criminal justice system, hospitalizations and institutional placements (SB 973, §1).*

- IMPACTS focuses on providing services to those individuals who utilize disproportionate criminal justice system and behavioral health system resources.
- Since 2019, IMPACTS has received \$10M in one-time funding from the Legislature each biennium.



*Research shows that individuals occupying this intersection utilize a disproportionate amount of resources from both systems.*

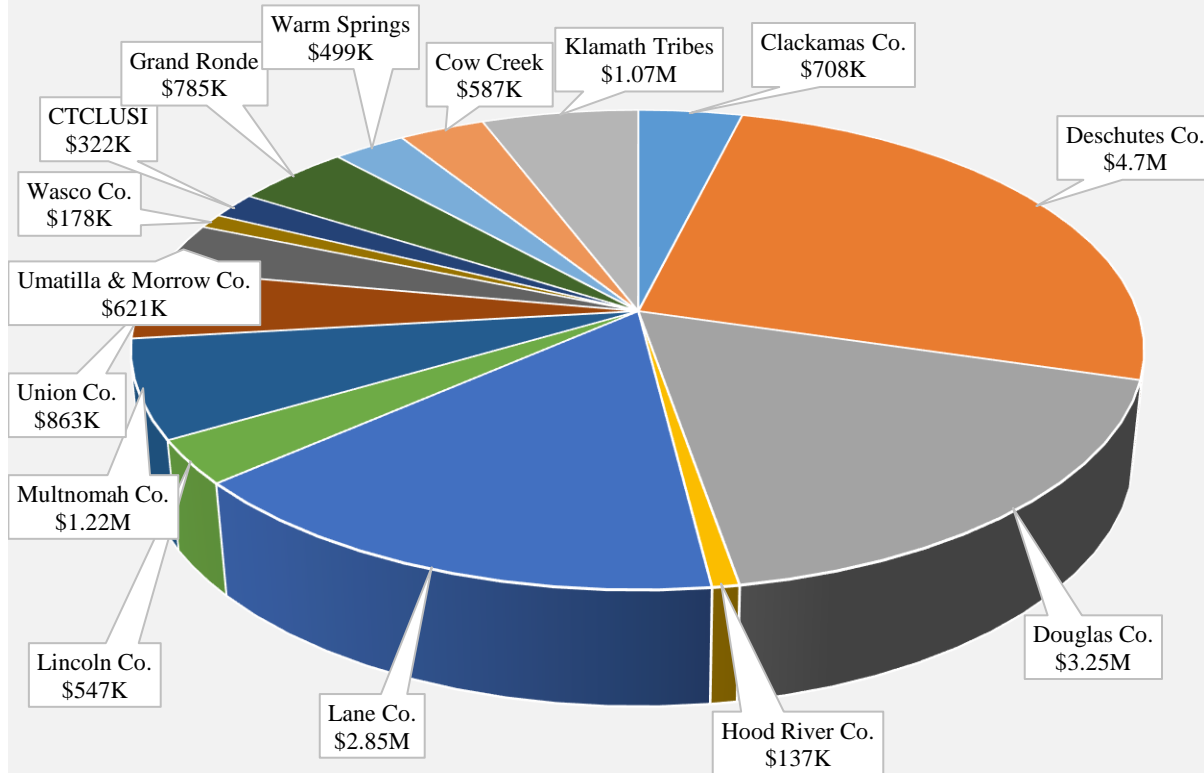

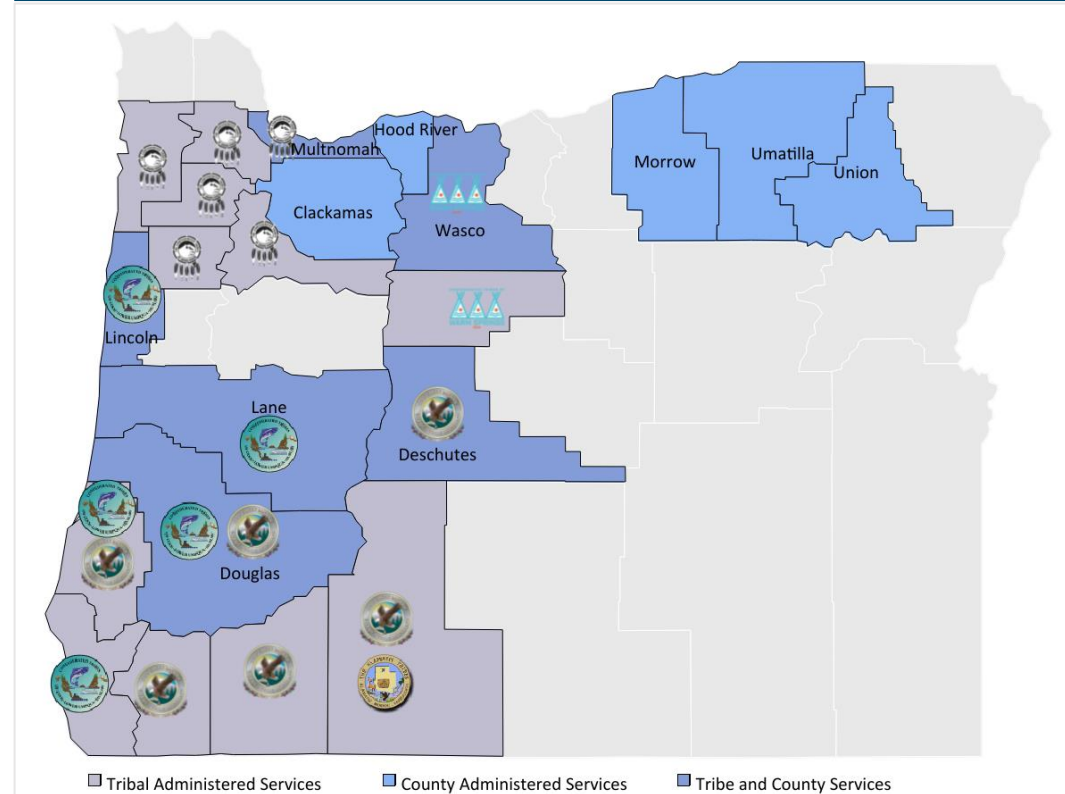

# IMPACTS Grant Program

## SELECT FUNDED PROGRAMS

### Lincoln County LEAD Program

- The LEAD Program promotes front end diversion of individuals engaged in low level criminal activity from the criminal justice system.
- While housed within the Sheriffs Office, referrals can come from any law enforcement agency within the county.
- Lincoln County LEAD works with ReConnections, a community-based treatment provider, to create individualized service plans, identify needs, and provide case management and peer services.
- ReConnections also connects clients with transitional housing and works to connect them with permanent housing when possible.





# IMPACTS Grant Program

## SELECT FUNDED PROGRAMS

### Deschutes County Stabilization Center

- IMPACTS funding supported the DCSC so that it could provide 24/7 services within the county.
- The program within the DCSC provides risk assessments, case management, 23-hour respite and crisis psychiatric appointments.
- The DCSC partners with the local jail, law enforcement, and local hospitals to connect high utilizers with services. The center is also co-located with the adult jail and county Forensic Diversion Team.
- Recently, the DCSC has partnered with local 911 to dispatch to calls with mental health components where appropriate.

# IMPACTS Grant Program

## SELECT FUNDED PROGRAMS

### Douglas County Intensive Care Coordination

- IMPACTS funding supported a dedicated Intensive Care Coordination (ICC) Team, which focuses on intercepting high utilizers before they enter the jail or emergency department and coordinates care for those individuals.
- The ICC Team partners with Adapt, who provides a 24/7 mobile crisis program with two mobile crisis vans, a sobering center, and restoration rooms. Adapt also recently added an outreach navigator for jail in-reach services.
- The Douglas County program also works to reconnect individuals with OHP, locate transitional and/or permanent housing, record expungement, employment assistance, and basic needs.





# IMPACTS Grant Program

## SELECT FUNDED PROGRAMS

### Lane County Forensic Intensive Treatment Team

- Within Lane County's behavioral health department, its FIT Team's mission is to provide mobile, compassionate, person-centered care anywhere in the community.
- The FIT Team provides proactive street outreach, jail in-reach, warm hand offs, mental/SUD treatment, therapy, medication, and peer support. The team also engages in complex case management but also often focuses on basic needs (e.g., housing referrals, tents, bus passes).
- The FIT Team consists of a clinical supervisor, three QMHPs, two peer support specialists, two jail-based qualified mental health associates/court liaisons, an office assistant, and a part-time psychiatric mental health nurse practitioner.

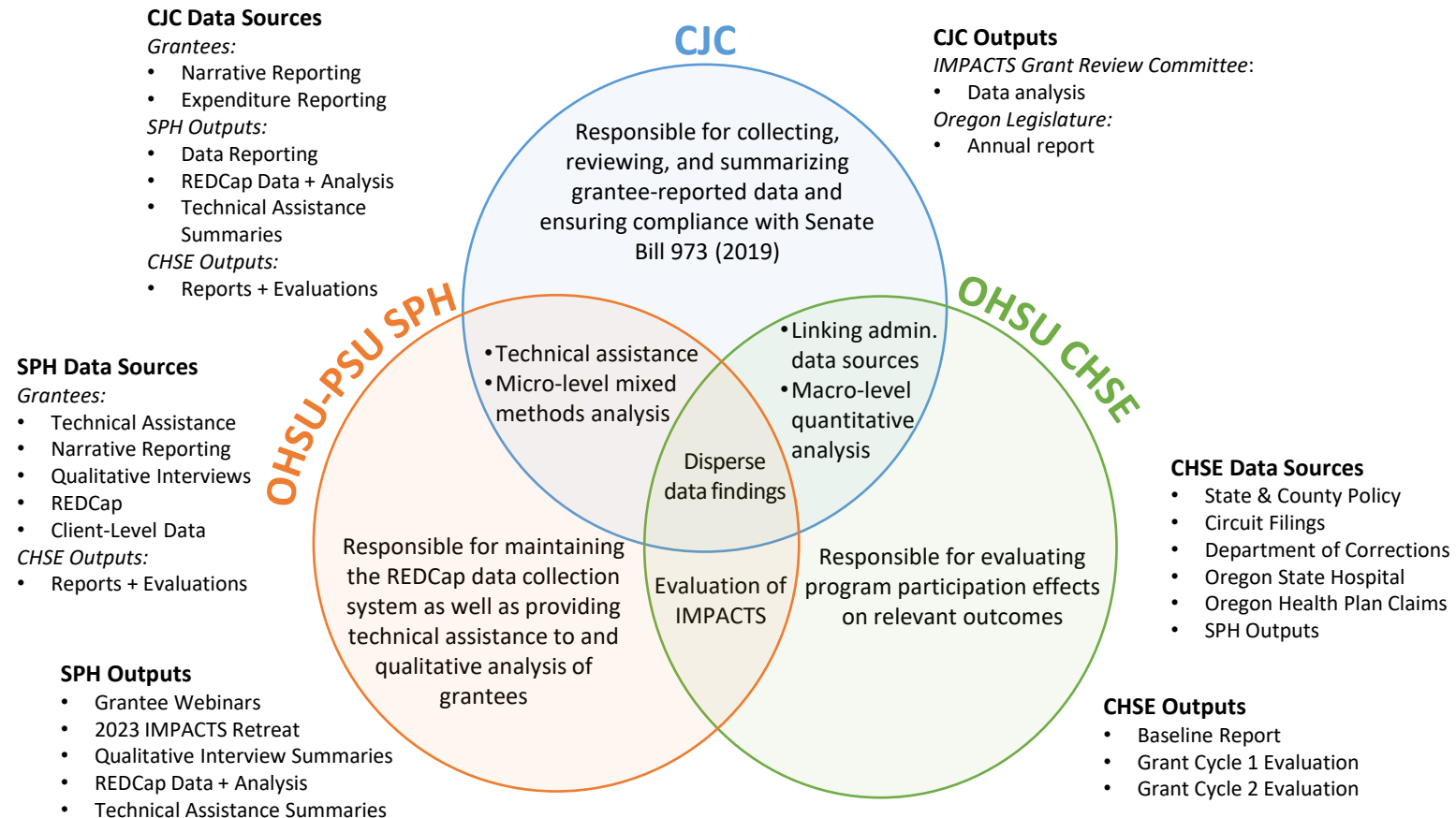


# IMPACTS Grant Program

## PROGRAM EVALUATION

- OHSU-PSU School of Public Health provides technical assistance to grantees, collects qualitative data, and maintains the REDCap data collection system used by grantees for data reporting.
- OHSU CHSE is currently providing evaluative support of both current grantees as well as monitoring state-level outcomes related to IMPACTS.
- The Commission acts as the central hub for all data collection and reporting.

# IMPACTS Grant Program

## CHARACTERISTICS OF CLIENTS SERVED

- Prior to enrollment in IMPACTS, clients utilized a significant amount of system resources.
- Over 72% of clients are known to have at least one mental health disorder and over 72% of clients are known to have an SUD.
- Nearly 50% of clients are referred to the program via public safety system encounters (e.g., jail, community corrections, law enforcement, court).
- Over one-third of clients were unhoused.

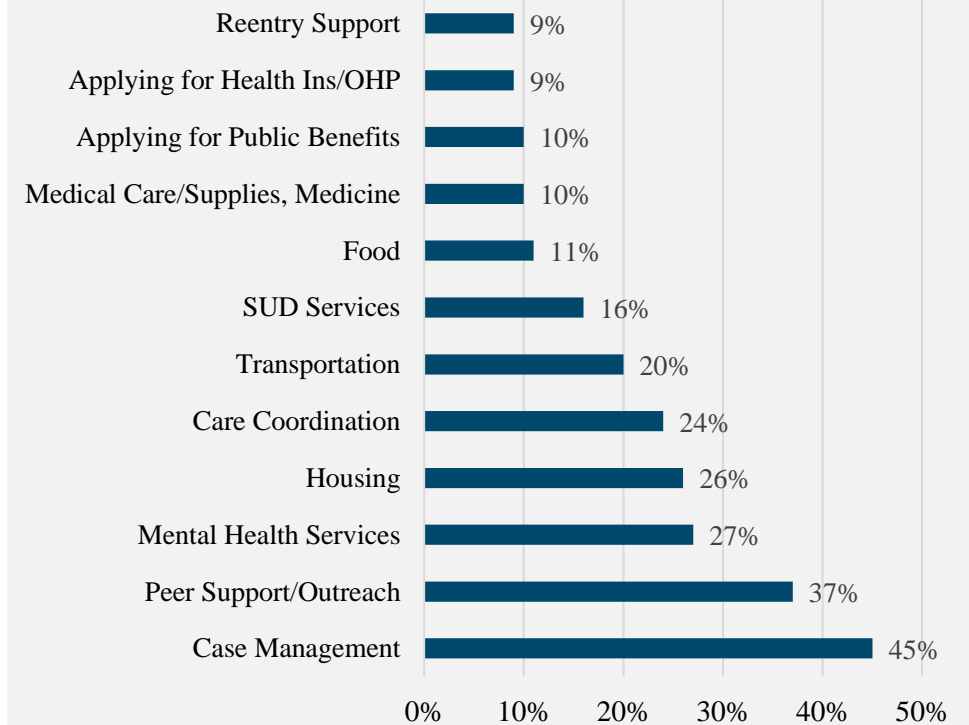

# IMPACTS Grant Program

## OUTCOMES AND SERVICES PROVIDED

- Client success is broadly defined and includes contacts, connections to services, connections to care, and diversion services.
- The most common services provided to clients initially are case management, peer support, mental health services, and housing support.
- Client retention is also a key aspect to IMPACTS, with nearly 50 percent remaining engaged within three months of enrollment.
