Subject: 2024 Committee Legislative Concepts

Note: This document has been updated to include a summary for LC 224.

LC 224 is a cannabis omnibus that directs the Oregon Liquor and Cannabis Commission (OLCC) to create and maintain a map of licensed marijuana and hemp grow sites, and to develop a methodology to distinguish between marijuana and industrial hemp; permits the Oregon Department of Agriculture (ODA) to enter into interagency agreements for carrying out OLCC inspections of hemp crops, and allows law enforcement and other authorized personnel to accompany ODA on hemp site visits; directs OLCC to establish a registration system for industrial hemp products that contain cannabinoids intended for human or animal consumption, and provides minimum packaging and labeling requirements; establishes per capita license limits for marijuana producers, processors, wholesalers, and retailers; and directs the OLCC to establish uniform standards for minor decoy operations to investigate sales of adult use cannabis items to minors; and directs OLCC to adopt rules for issuing temporary permits to marijuana licensee and laboratory workers. (Dated 1/12/24.)

**LC 256** permits the Oregon State Police to submit fingerprints of participants in Oregon's voluntary Record of Arrest and Prosecution Background (Rap Back) program to the Federal Bureau of Investigation's (FBI) Rap Back system and permits the FBI to retain those fingerprints for the purpose of future search submissions. (Dated 12/28/23).

**LC 260** appropriates money to the Department of Justice to fund the Sexual Assault Task Force's management of the Oregon Sexual Assault Examiner/ Sexual Assault Nurse Examiner Certification Commission. (Dated 1/4/24).
