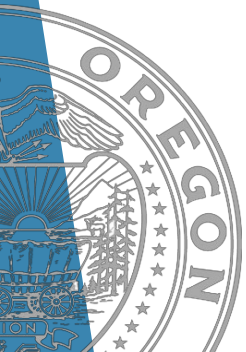

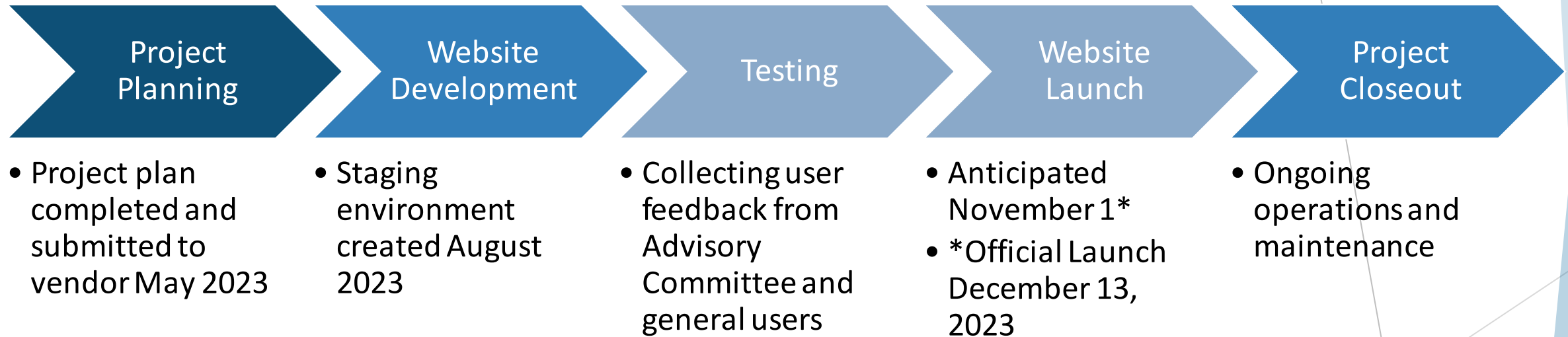
Transparency Website Redesign Goals

Goal: One-stop, searchable access to comprehensive information on government spending and activities

- ▶ Generate intuitive, high-quality image elements, content, and dataset visualizations
- ▶ Redefine intuitive top-access navigation
- ▶ Design a modern look and feel with user-centered content modules
- ▶ Integrate user experience tools and visualizations
- ▶ Verify and deploy best practice web content accessibility guidelines (WCAG 2.0)

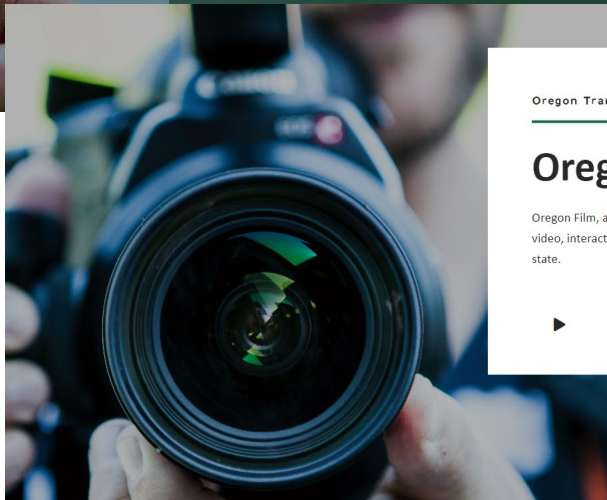


Oregon Transparency Highlight

Oregon Film

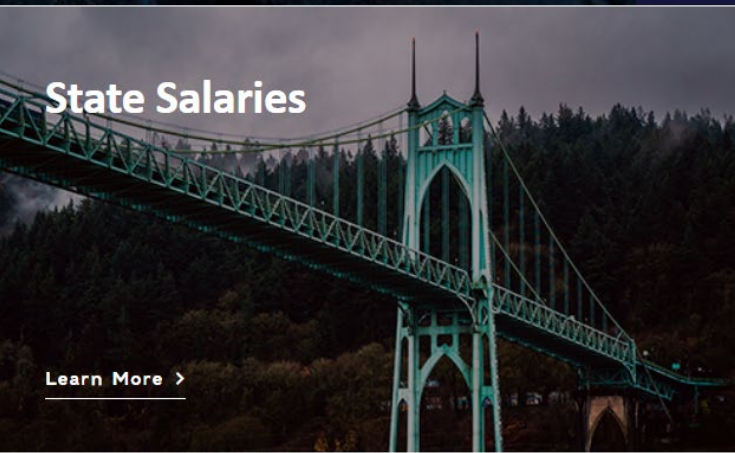
Oregon Film, a state agency, promotes, supports and advances the film, video, interactive, animation and creative content industries within the state.

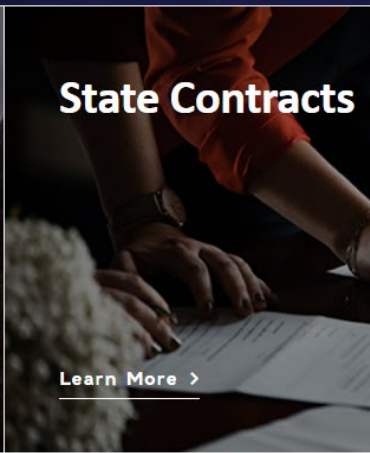

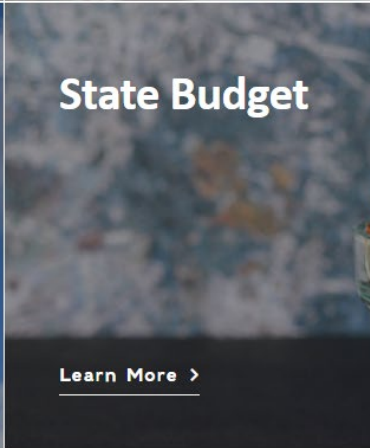

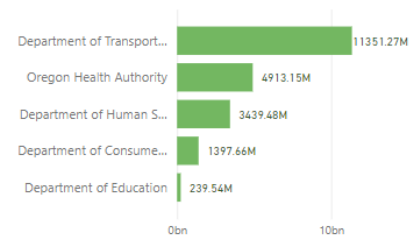

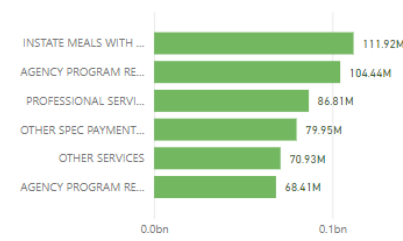

At-A-Glance: State Purchase Orders - State Expenditures - State Funding Sources

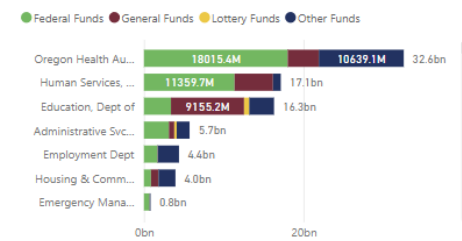
State Purchase Order Totals By Organization

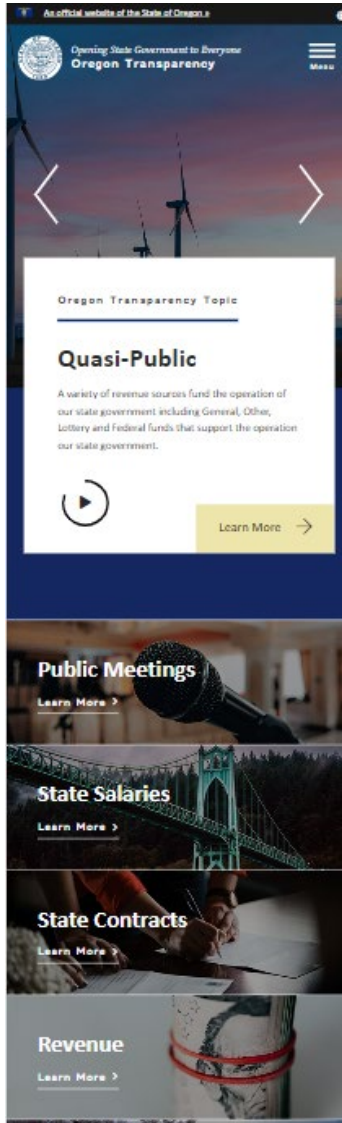

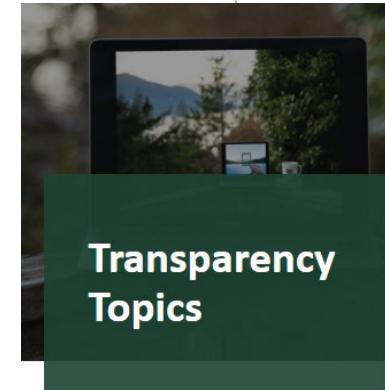

Did you know...

What can you find in the Agency Expenditures report?

- All payments for fiscal years 2019 - 2022, applied to an expense account within SFMA for the agency.
- Payments to individuals identified in the system

What data is not provided in this report?

- Payments to employees whose records are specifically protected from disclosure based on a protective court order were removed.
- Any payment that did not include a vendor name within SFMA was removed.
- System entries related to vendors with negative amounts (i.e., credit amounts) were removed.

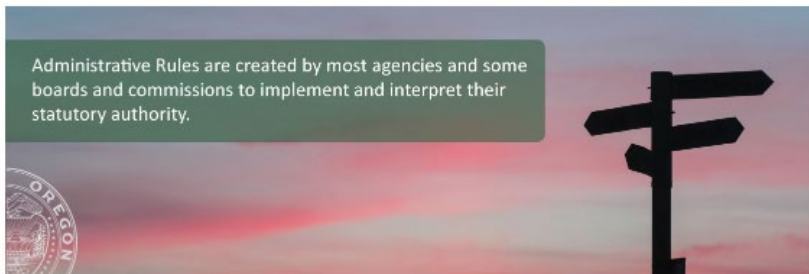

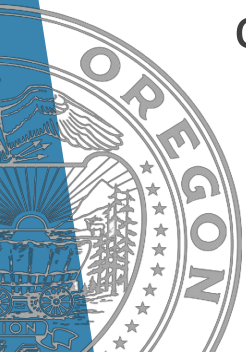
Transparency Program Vision and Outcomes

- ▶ **Vision:** The Oregon Transparency Website provides constituents the ability to meaningfully engage with and learn about how state government operates.
- ▶ **Transparency Outcomes**
 - Published data is timely, accurate and complete with appropriate context and metadata.
 - Published data is reflective of how state government operates and provides constituents the tools to learn about state government financial operations.
 - Proactive transparency is modeled through publication of open datasets that reflect user needs.



Future Enhancements

- ▶ Expand on the visualization and interactivity within the current site by continuing to develop dashboards and other visualizations.
- ▶ Identify future opportunities to expand data collection and timeliness by prioritizing datasets and data stewards to channel into open data publication services.
- ▶ Examine opportunities for partnership with state agencies to enhance transparency practices.
- ▶ Collaborate with E-Government to evaluate opportunities for feedback through focus groups, surveys, and other constituent outreach options.
