#### **Executive Order**

- The Council shall recommend an action plan to guide awareness, education, and usage of artificial intelligence in state government that aligns with the State's policies, goals, and values and supports public services to deliver customer service more efficiently and effectively.
- The recommended action plan shall include concrete executive actions, policies, and investments needed to leverage artificial intelligence while honoring transparency, privacy, and diversity, equity, and inclusion.
  - Council must have a commitment to data ethics and data equity.




#### Strengthening our Data Foundation

- Reviewing draft data governance structure against current GIS data governance structures and building alignment






