What is System of Care?


- System of Care is....
 - A philosophy based on cross system collaboration that supports youth and families who
 have complex and significant behavioral and mental health needs.
 - A set of values
 - An organizational structure to address system barriers
- The goal is to create an effective continuum of services and supports that are youth- and family-driven, community-based, and culturally and linguistically responsive.
- Priority focus on children and youth who are involved in 3 or more state funded systems

- 4 Pillars from our current Strategic Plan:
 - Youth & Family centered
 - Services and supports are integrated and collaborative to meet needs identified by youth and families.
 - Services and supports are community based and provided at the lowest level of intensity possible.
 - Culturally responsive, linguistically appropriate, trauma-aware services and supports
- Focus on youth with the highest needs those involved with multiple systems and those from underserved or marginalized communities.
- Informed by available data.
- Collaborate with Alcohol and Drug Policy Commission (ADPC) to develop a strategy to prevent and treat substance use disorders for youth (HB 4002).

Primary Purpose of SOCAC

Senate Bill 1 (2019)

- The primary duty of the Council is to develop and maintain a state system of care policy and a comprehensive, long-range plan for a coordinated state system of care that encompasses public health, health systems, child welfare, education, juvenile justice and services and supports for mental and behavioral health and people with intellectual or developmental disabilities.
- Next SOCAC Strategic Plan due Jan 1, 2026

Local Systems of Care (SOC)

- Local SOCs are required by CCO contract
- Convene local cross system partners in behavioral health, child welfare, I/DD, juvenile justice and education
- Center youth and family voice
- Address barriers to services and supports and elevate unresolved barriers to SOCAC when needed
- Utilize grants from SOCAC to support local efforts, like emergent social needs
- Advocate for policy and system change

- Crisis Response: Temporary Lodging, Residential Treatment Access

Engaging System Partners

- Oregon is not unique in our behavioral health crisis
- Emergency room boarding and temporary lodging are problems in every state
- State agencies are siloed by division and funding, even system partners are confused at times!
- Responsibility and authority often aren't aligned
- Resistance to shared responsibility 'they're working on that'
- Three major challenges: rates, regulations, relationships

30% for kids
