Re: Testimony re HB 4002 Implementation – Symposium Update

Co-Chairs Lieber and Kropf and Members of the Committee,

For the record, my name is Kevin Campbell. I am the Executive Director for the Oregon Association Chiefs of Police and I have the privilege of representing Oregon's Chiefs of Police and Sheriffs in the Oregon legislative process. I am here today to provide brief testimony regarding the implementation of HB 4002 with a focus on efforts to stand up pre-charge deflection programs in counties throughout the state.

Let me begin by thanking this committee for your work during the 2024 Legislative Session to craft a comprehensive policy and funding package designed to meaningfully address Oregon's daunting addiction and community livability crisis. While I will be focused today on our preparations to implement deflection programs in anticipation of September 1st effective date for the new Drug Enforcement Misdemeanor, I want to recognize that HB 4002 and HB 5204, the companion funding measure, included several critically important components including tools to interdict and prosecute drug distribution, funding for Medically Assisted Treatment programs in our Jails, funding for shovel ready projects designed to increase inpatient drug treatment and stabilization beds throughout the state, and more. Thank you!

On May 9th, the Oregon District Attorney's Association, Oregon Association Chiefs of Police, Oregon State Sheriffs' Association, League of Oregon Cities and the Department of Public Safety Standards and Training hosted a HB 4002 Implementation Symposium titled "a Deep Dive into deflection and Law Enforcement Assisted Diversion Programs". The daylong symposium was attended by over 330 participants and included representatives from behavioral health, local government, law enforcement, community-based organizations and our state agency partners. Impressively, 33 of the 36 counties

were represented at the event, signs that there is active efforts to stand up deflection programs.

The symposium program included a series of presentations including:

- Evidenced-Based Substance Use Treatment and Deflection Dr. Hoover ECHO/OHSU
- Deflection from a Behavioral Health System Perspective Panel Discussion.
- A segment featuring organizations and agencies who are resources and partners in the implementation process.
