Procedures: HB 4001

Quorum

- A majority of task force members (10 out of 19 members)

Official Action

- Requires a vote of approval by a majority of task force members (10 out of 19 members)

Chair

- Elected by Task Force members
- Specifies time and place of meeting

Vacancies

- Appointed by the relevant authority effective immediately

Adoption of Rules

- Adopted by the Task Force as necessary for operation

HB 4001 Provisions: Scope of Inquiry

Funding Mechanism

- Identification of the most appropriate funding mechanism to ensure long-term stability of specialty courts within this state.

Funding & Administrative Balance

- Determining the administrative and funding balance between the Oregon Criminal Justice Commission and the Judicial Department.

Current Metrics

- Determining whether specialty courts currently use the right eligibility metrics, including whether current metrics are accurately capturing those individuals who would benefit from a drug court program.

Accountability Mechanism

- Identification of the appropriate accountability mechanism to ensure that specialty courts are operating according to the standards of the commission.

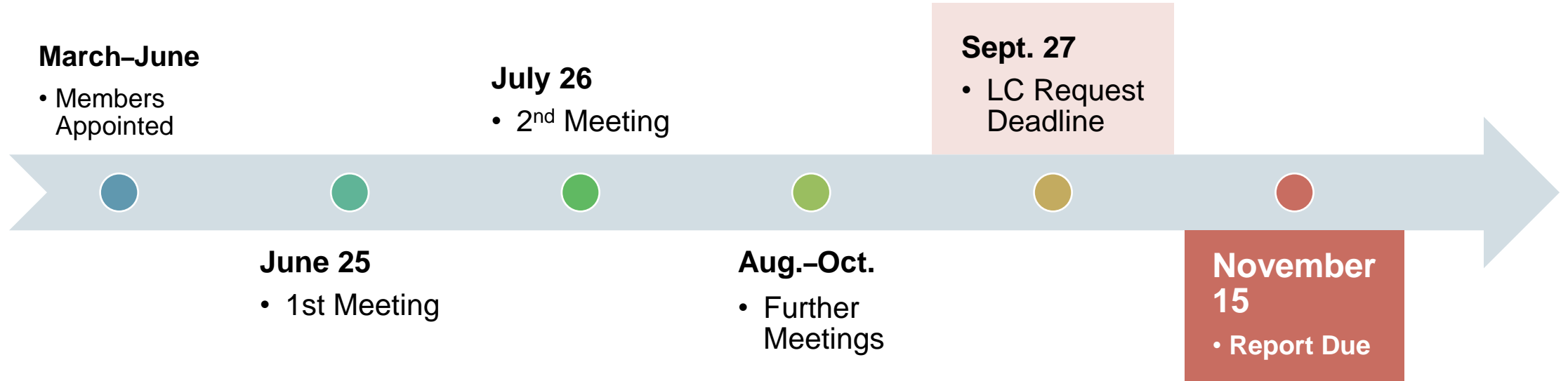

HB 4001 Provisions: Timeline & Report



“No later than **November 15, 2024, the task force shall submit a report on its findings and recommendations, which may include recommendations for legislation, in the manner provided by ORS 192.245, to the interim committees of the Legislative Assembly related to the judiciary.” HB 4001 Section 1(10).**
