

OCPA Enactment



Oregon Consumer Privacy Act (OCPA): a comprehensive consumer privacy law giving rights to individual consumers to actively manage the personal and sensitive data companies keep about them

- -Passed in 2023 (SB 619)
- -Went into effect July 1, 2024
- -Will go into effect for non-profits July 1, 2025
- -Cure period in effect until January 1, 2026

Oregon vs. Other State Privacy Laws

AS OF JULY 2024, 19 STATES HAVE PASSED COMPREHENSIVE DATA PRIVACY LAWS

The OCPA vs. Other State Privacy Laws

- Oregon's statute was innovative in many ways:
 - Broader definition of "biometric data"
 - Expanded definition of "personal data"
 - New categories of sensitive data
 - Limited scope of entity-level exemptions
 - "Right to Know" specific third parties

The OCPA vs. Other State Privacy Laws

- Subsequent laws have strengthened:
 - Protections for children up to 17 years of age
 - Data minimization requirements
 - Limitations on collection and use of health-related information
- Applicability thresholds

Oregon Consumer Privacy Law

As announced on June 23, 2023, the Oregon Legislature passed Senate Bill 619 », a consumer privacy law (the "Oregon Consumer Privacy Act" or "the law"). Senate Bill 619 was developed by the Attorney General's Consumer Privacy Task Force working with 150 consumer privacy experts and stakeholders to answer the call for comprehensive consumer privacy legislation. The Oregon Consumer Privacy Act (OCPA), ORS 646A.570-646A.589 », was signed into law by Governor Kotek and takes effect on July 1, 2024.







*NUMBERS CURRENT THROUGH SEPTEMBER 18










- -Cure period until Jan. 1, 2026
 - Discretionary
 - Can a problem be cured?
 - Privacy notice outdated
 - Technical issues with addressing privacy rights, etc.
- -Sometimes an inquiry letter is sent for additional information
- -If something cannot be cured, then we can move directly to a formal investigation/enforcement process
 - If a business does not cure an identified issue, we can also then move to investigation/enforcement


Outreach & Education: Consumers

The OCPA does not work unless consumers 1.) know about their privacy rights, 2.) know how to request them, 3.) can report to us when specific businesses are deficient.
