





DATE OF SPECIE ATE

Temporary Licenses

• Not currently allowed in rule.

Out-of-State Licenses

- Oregon does recognize out of state practice of pharmacy.
- For **reciprocity**, pharmacists must have been engaged in the practice of pharmacy for at least 12 months with a minimum of 1440 hours of work experience as a licensed Pharmacist.
- For **initial licensure**, applicants must have completed <u>a minimum of 1440 hours in an Internship Program</u>.


Interstate Compacts

• Oregon does not participate in a **multistate licensing compact**, or "mutual recognition agreement."

INTERSTATE COMPACTS




- In the current regulatory environment, pharmacists and technicians must maintain their original license and then meet a variety of requirements to obtain an additional license in each state they wish to provide services.
- Idaho is the only state that grants automatic mutual recognition of outof-state pharmacists to practice in the state.
- Concerns about interstate licensing compacts include:
 - Potentially inconsistent regulatory oversight
 - Interstate discrepancies in standards of practice
 - "Practice of Pharmacy" varies from state to state
 - Revenue loss (OBOP is an "other-funded" agency)
