
# OREGON MEDICAL BOARD INTRODUCTION

14 Governor-appointed, Senate-confirmed, dedicated public servants who volunteer their time in the best interest of Oregonians

40 agency employees focused on efficiently and effectively licensing medical professionals and thoroughly and thoughtfully investigating patient safety concerns

#### LICENSING BASICS: THE NUMBERS

#### 27,202 Licensees as of July 1, 2024



Established in 1889 to regulate the practice of medicine (ORS 677).

The OMB licenses and regulates more than 27,000 Medical Doctors (MD), Doctors of Osteopathic Medicine (DO), Doctors of Podiatric Medicine (DPM), Physician Associates (PA), and Acupuncturists (LAc).

In 2023, the Board welcomed to Oregon 1,519 MDs, 337 PAs, 309 DOs, 72 LAcs, and 15 DPMs, for a total of 2,252 new licensees.

Board staff renewed 23,290 licenses in 2023.

### LICENSING BASICS: CUSTOMER SERVICE

OMB licensing staff is composed of **10 employees**, each trained to process licenses and renewals:

- 1 Licensing Manager;
- 6 Licensing Specialists; and
- 3 Licensing Representatives (Call Center).

The OMB prides itself on strong customer service. Each phone call is answered by a staff member so that applicants, licensees, and the public speak with a person. Email responses are most often on the same day and no later than 2 business days.

In 2023, licensing staff responded to **24,545 emails** and answered **12,933 telephone calls**.



# APPLICATION/RENEWAL PROCESS: LICENSE FEES

Applications and Renewals are **online** through the Applicant/Licensee Service Portal. Licensure costs depend on the license being applied for:



# APPLICATION/RENEWAL PROCESS: TIMELINES

#### **Application Processing Timelines:**

Timeframe	2022	2024	
Processing Applications Received	5 Business Days	2-3 Business Days	
License Approvals	1 business day	1 business day	
Overall Process Averages*	3 months	2 months	
Internal and External Barriers	Staffing	Staffing	

#### **Renewal Process:**

- Occurs every two years.
- Licensing staff renewed 23,284 licenses between September 2023 and September 2024.
- The average processing time for license renewals is 2 business days.
- Renewal late fees depend on the license being applied for:
  - MDs, DOs, and DPMs = \$195
  - PAs and LAcs = \$80

# **Supporting Applicants and Licensees through the Application Process**

On June 1, 2023, the Board officially changed its license and renewal applications to remove intrusive and stigmatizing questions around mental health care and treatment.

The applications now offer an advisory statement with supportive language around mental health. Licensees and applicants are accountable for their own well-being.


# APPLICATION/RENEWAL PROCESS: EFFORTS UNDERWAY

#### Database Replacement/ Upgrade Underway

- Ultimately will offer increased functionality (API with national databases)
- More user-friendly interface for applicants and licensing staff
- Possibility for credentialing organizations to access OMB data for source information




# APPLICATION/RENEWAL PROCESS: APPLICATION GROWTH



### **OUT-OF-STATE LICENSES: INTERSTATE COMPACT**

The Interstate Medical Licensure Compact (IMLC) would limit existing strategies OMB uses to ensure medical providers are safe and competent.



#### Reduced standards for licensure:

- No review of malpractice claims, employment history (including sexual misconduct), criminal history, or NPDB
- Cannot require re-entry plans
- Inability to monitor impaired licensees

#### Additional concerns:

- Medical practice act differences between Compact states (Dobbs v. Jackson)
- Mandatory sharing of information between Compact states
- Automatic suspensions triggered by disciplinary actions in Compact states
- Inaccurate data
- Slow processing times
- No access to source documents (e.g. for credentialing)

# OUT-OF-STATE LICENSES: FREE/EXPEDITED/EXEMPT

#### Temporary (FREE) Licenses/Authorizations


- To obtain or provide training (outside of a residency program)
   30 days/year
- To serve as a medical expert in civil or criminal litigation 30 days/year
- To provide care during & immediately following a declared emergency emergency + 90 days
- To volunteer at a non-profit organization 5 days/year
- To volunteer with a coordinating organization 30 days/year

#### **Out-of-State Licensees**

- Expedited Endorsement primary source verification of core credentials is waived
- Telemedicine Licenses

#### **License Exemptions**

• Exemptions for Telemedicine continuity of care
