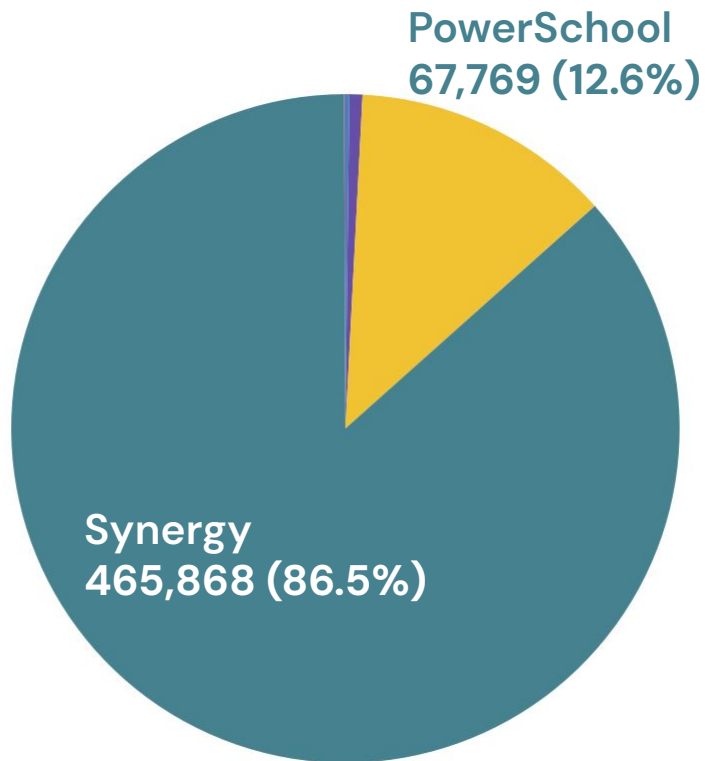

People, Timeline, and Contract

Oregon Student Information System (OSIS) People

Groups and Meetings

- **Workgroups:** Dozens, by topic, hundreds of district and ESD staff
- **Steering Committee:** 56 individuals who meet weekly on Monday afternoons, with Edupoint (Synergy) leadership
- **Executive Council:** 5–8 CIOs who meet monthly to focus on contract management, future planning, and cost sharing

Timeline

- **2010–2012:** RFP, Contract Award, and Steering Committee formed
- **2018:** Successful five year contract renewal, notable additions included information security requirements that were ahead of the national effort on cybersecurity
- **2023:** Successful five year contract renewal

We were curious about the scale of stories we were hearing about delays in records transfer and student services. We asked districts for transfer volume. This example from Portland Public Schools (~50k students) illustrates a pattern.

Student Migration across Oregon

Family experience is the heart of our work.

Using ODE's June 2024 total of 538,445 students, with an approximate mobility rate of 14% for Oregon's students, we believe that if we get this right, we:

- support improved outcomes for **~75,000 Oregon students** (and thousands of families) a year
- increase efficiency and data accuracy AND save significant hours of manual data entry per district
- increase student data privacy

The Bigger Picture (Gaps)

State Reporting in Oregon

With our data standards work to improve the student and family experience, we also:

- Increase efficiency and data accuracy for schools and ESDs
- Increase student data privacy
- Prepare to support ODE in modernizing state reporting*—and access to data— for education leaders, policymakers, and communities

*For the 2024–25 school year:

- There are **319 reports** on the official submissions calendar
- Those reports are submitted via **31 file formats and systems**
- Many of them require **50 columns of data** (student identifiers) before the data element(s) being collected for a specific report

Opportunities

ODE K-12 and Higher Education Data Transfers

Our work designing the student record exchange makes it possible in future years for us to transport data more efficiently to:

- HECC for transcript and college admission data
- ODE for state reporting data

Supporting Improved Student Outcomes

We have years of Synergy stability in the OSIS distributed governance model. Oregon's PowerSchool districts have professional connections via Willamette ESD and the Oregon Data Suite for similar stability.

We are ready to partner with ODE on modernizing how we do this work together that supports students, families, educators, and communities.
