A few thoughts about State response to Transportation issues and its impact on Rural transportation in Clackamas County and the State of Oregon.

Clackamas County is not just the" Town Center" or site of County buildings, New Court house, cities, but a very large unincorporated rural populated area. Almost half of Clackamas County is "Rural" with extensive agricultural lands and traffic that are getting overlooked when it comes to transportation impacts and solutions. As more and more people are pushed to these rural areas along with their traffic impacts, most of the infrastructure investments seldom find their way to ease "Rural" issues and stop at the Metro and or Cities Boundaries.

Now rural roads are seeing more and more urban-level traffic that they weren't designed to accommodate this daily urban flow to the rural areas. Which of course has caused a wide range of difficulties brought on by roads not design for this kind of traffic. Open ditches, narrow shoulders, no safe pedestrian paths to name just a few and recently brought to light by ODOT's lack of well-funded and thought out proposed mitigation in regards to I-205 diversion on our rural roads was considered very poor at best.

I would like to see a concentrated effort to include improving "Rural impacted routes" before any new roads are funded. To add "New" roads without maintaining the "Old" roads will only add to our crumbling infrastructure.

This is nothing new to our family and community. Next June we will celebrate 125 years as the JP and Susie Cook Family Farm. A Clackamas County Century Farm, listed on the National Register of Historic Places, State and County Heritage Tree Grove. Our history goes way back when talking Clackamas County Roads. My grandfather William B. Cook Sr. championed a roads campaign before becoming Clackamas County Assessor for 12 years. (see below)
