Thanks to all participating members

Having served on three Transportation issues, the Oregon City Bypass as Director, Highway 212 re-alignment, as well as consulting on Hwy 217 / I5 ramp re-alignment, I include these statements.

The original Sustainable Transportation plan, was designed with an incorrect premise. The premise included the use of the 1000 Friends of Oregon, as a backstop against private business. This is noted in the attached document provided here. Sustainable Development is an off chute of international political methodology. Two differing political methodologies, one in deception of the future agenda, is to a great degree why we are here. I note this as 1000 Friends of Oregon trained some of the individuals testifying before you. This bias must be adjudicated for any success in your works.

When a project is predicated on an incorrect or false or mis-leading premise the later attempted solutions will be imperfect and repeat. Not all aspects of International policies or other political agendas belong in a States structural processes, as the largest percentage of citizens is not actually heard.

The Document:

How did much of this occur with little fanfare, necessary to implement fair and realistic solutions for this committee? Political conflict and Military conflict must be understood as twins in the use of deception

to secure their objectives. A bit of history to assist in explaining this, as transparency is paramount in the gaining of a rational, not ideological pathway to an all encompassing solution. We all were taught under these three principles from UNESCO. This is part of the challenge to rational goals in any large event.

- 1946 - UNESCO Education is instituted. 1946 - 1948: 1948: UNESCO: Its Purpose and Its Philosophy by Sir Julian Huxley (the first director-general of UNESCO, 1946-1948) is published, in which Huxley declares: "The general philosophy of UNESCO should be a scientific world humanism, global in extent and evolutionary in background... Political unification in some sort of world government will be required...Tasks for the media division of UNESCO (will be) to promote the growth of a common outlook shared by all nations and cultures...to help the emergence of a single world culture... Even though it is quite true that any radical eugenic policy will be for many years politically and psychologically impossible, it will be important for UNESCO to see that the eugenic problem is examined with the greatest care, and that the public mind is informed of the issues at stake so that much that now is unthinkable may at least become thinkable." Excerpts from this volume were reproduced under the title, "A New World Vision" (The Humanist, March/April 1979), and the Fabian Socialist Huxley, who was named 1962 "Humanist of the Year," elsewhere said that humanism's "keynote, the central concept to which all its details are related, is evolution." Also, it was Sir Julian Huxley (brother of Brave New World author Aldous Huxley, and grandson of Thomas Huxley who was known as "Darwin's Bulldog" because of his defense of evolution).

In conclusion, we must build the future with clear eyes, not the interference of Environmentalism over Stewardship. Much of the fractured state of things is in the difference between Environmental rigidity picking winners and losers, and the higher need for protection off all species, including humanity. in the review of all the activities, one should note that only humanity is the typical underclass.

Being a native of this State, with ancestors as far back as 1843, place this material in the record, to in some way assist through my experiences, and desire for a true conversation with all Oregonians.
