## LAND CONSERVATION AND DEVELOPMENT COMMISSION

---

The Governor has appointed the following individual to the Land Conservation and Development Commission subject to Senate confirmation.<sup>1</sup>

### New Appointee

Mark Bennett of Unity

### Term

July 1, 2024 – June 30, 2028

### Statement of Economic Interest<sup>2</sup>

### Composition<sup>3</sup>

The commission consists of seven members, including:

- one representative of Clatsop, Columbia, Coos, Curry, Lincoln, and Tillamook Counties, and Douglas and Lane Counties west of the summit of the Coast Range (THOMPSON);
- two representatives of Clackamas, Multnomah, and Washington Counties (HALLOVÁ, LAZO);
- one representative of Benton, Linn, Marion, Polk, and Yamhill Counties, and of Lane County east of the summit of the Coast Range (WARREN);
- one representative of Jackson and Josephine Counties, and Douglas County east of the summit of the Coast Range (PORTER);
- one representative of Baker, Crook, Deschutes, Gilliam, Grant, Harney, Hood River, Jefferson, Klamath, Lake, Malheur, Morrow, Sherman, Umatilla, Union, Wallowa, Wasco, and Wheeler Counties (**BENNETT**); and

- one representative of Benton, Clackamas, Linn, Marion, Multnomah, Polk, Washington, and Yamhill Counties, and Lane County east of the summit of the Coast Range (BOYER).

Membership must include at least one current or former Oregon elected city official and at least one current elected county official (THOMPSON). Members serve four-year terms and may be removed for cause. The commission selects its chair and vice chair.<sup>4</sup>

### **Duties<sup>5</sup>**

The commission adopts state land-use goals and implements rules, assures local plan compliance with the goals, coordinates state and local planning, and oversees the coastal zone management program. The commission must:

- advise the Director of the Department of Land Conservation and Development;
- adopt rules and appoint advisory committees;
- cooperate with federal, state, and local governments;
- adopt and amend goals consistent with regional, county, and city concerns;
- prepare, collect, and provide land use inventories;
- prepare statewide planning guidelines and coordinate planning efforts;
- review comprehensive plans for compliance;
- ensure widespread citizen involvement in all phases of the process;
- review and recommend areas of critical concern to the Legislative Assembly;
- report to the Legislative Assembly; and
- review the land use planning responsibilities and authorities given to the state.

The commission may:

- apply for and receive moneys from state and federal governments;
- contract with public agencies and outside parties for services;
- develop model land use regulations; and
- review comprehensive plan and land use regulations related to identifying and designating high-value farmland.
