Composition³

The board consists of 17 members. including: 4

- one Oregon university faculty member who is not involved in the direct delivery of health care (CALDWELL);
- two health care group purchasers, one of whom shall be employed by a
 governmental entity, and neither of whom provide direct health care services or
 have an immediate family member who does (BUI, VACANT);
- two health care consumers, neither of whom provide direct health care services or have an immediate family member who does (DAYTON, MORRIS);

- two health insurers, including a domestic not-for-profit health care service contractor, a domestic insurance company licensed to transact health insurance, or a health maintenance organization (ENGRAV, MARVIN);
- one representative of a statewide or national labor organization (HURST);
- two active licensed physicians (CHADAGA, DANNENHOFFER);
- two hospital administrators or their designees (MIKULA, STEEN);
- one licensed pharmacist (HUFFT);
- one ambulatory surgical center or outpatient renal dialysis facility representative (KETCHUM);
- one active licensed nurse (BYERS);
- one licensed nursing home administrator or nursing home director of nursing services (SPRANDO); and
- the State Public Health Officer or designee (SELOVER).

Members serve four-year terms and are eligible for reappointment. The board selects its chair and vice chair. No voting member may be an employee of the commission.

Duties⁵

The Oregon Patient Safety Commission is a semi-independent state agency that improves patient safety by reducing the risk of serious adverse events occurring in Oregon's health care system and by encouraging a culture of patient safety. The board exercises the power of, and provides governance to, the commission.

The board must:

- adopt rules necessary for the implementation of the Oregon Patient Safety Reporting Program;
- maintain the confidentiality of all patient safety data; and
- appoint a commission administrator.
