RESPIRATORY THERAPIST AND POLYSOMNOGRAPHIC TECHNOLOGIST LICENSING BOARD

The Governor has appointed the following individual to the Respiratory Therapist and Polysomnographic Technologist Licensing Board subject to Senate confirmation.¹

Composition³

The board consists of seven Oregon residents, including:

- three respiratory care practitioners (BURTON, ERICKSON, FREIMARK);
- two polysomnography practitioners (EASBEY, **STONE**);
- one qualified medical director for polysomnography or for respiratory care (LEFOR); and
- one member of the general public (HERRERA-FUENTES).

Members serve four-year terms. The board selects its chair and vice chair. Board members may be selected by the Governor from a list of three to five nominees for each vacancy, submitted by the Oregon Society for Respiratory Care or another professional organization representing respiratory care practitioners or polysomnographic technologists.

Duties⁴

The board oversees the practices of respiratory therapists and polysomnographic technologists. The board must:

- establish standards of practice and professional responsibility for persons licensed by the Health Licensing Office; and
- provide for waivers of examinations, grandfathering requirements, and temporary licenses as considered appropriate.
