## STATE AVIATION BOARD

The Governor has appointed the following individual to the State Aviation Board subject to Senate confirmation.<sup>1</sup>

## **New Appointee**

Brian Prange of Hood River

#### **Term**

July 1, 2024 - June 30, 2028

## **Appointment/Confirmation Authority**

ORS 835.102 (2023)

#### Statement of Economic Interest<sup>2</sup>

Not required.

## Statutory Requirements<sup>3</sup>

The board consists of seven members appointed to represent both public and private aviation interests. Membership requires:

- no more than four members in the same political party, and considering different geographic regions of the state (GRAUPP (N/A), KNIGHT (N/A), NAGY (D), LUCAS (R), PRANGE (R), STEPHENS (D)); and
- one resident from east of the Cascade Range (PRICHER (N/A));

Members serve four-year terms<sup>4</sup>; the Governor designates a chair and vice chair; a majority of members constitutes a quorum; and the board must meet at least once quarterly.

#### **Duties**<sup>5</sup>

The board provides policy oversight for the Oregon Department of Aviation (ODAV). Its duties include:

- incorporating a plan for the development of airports, state airways, airplane industries, and general aviation with ODAV's advice;
- cooperating with, and assisting, federal and local governments, and others in the development of aviation activities, through ODAV;
- overseeing ODAV administration, including authorizing contracts and the receipt and use of federal funds and moneys in the State Aviation Account;
- performing its duties commensurate with and for the purpose of protecting the general public and the safety of persons receiving instruction for operating or traveling in aircraft, and developing and promoting aviation; and
- establishing rules governing seaplane safety and operations in state waters, in consultation with the State Marine Board and the State Parks and Recreation Department.

#### The board may also:6

- perform such acts, adopt or amend and issue such orders, rules and regulations, and make, promulgate, and amend such minimum standards as it considers necessary to perform its statutory duties; and
- fix the compensation of the director of the department.
