## BOARD OF BOILER RULES

---

The Governor has appointed the following individuals to the Board of Boiler Rules subject to Senate confirmation.<sup>1</sup>

### New Appointee

Curt Beach of Cornelius

### Reappointee

Ryan Garvey of Portland

### Terms

Beach: October 1, 2024 – September 30, 2028

Garvey: May 25, 2022 – May 24, 2026

### Composition<sup>3</sup>

The board has 12 members, including:

- one owner and user (or representative of) of a high pressure boiler, with practical experience with high pressure boilers (LANGLEY);
- one manufacturer (or representative of) of boilers or of pressure vessels (HENDRIX);
- one boilers and pressure vessels inspector, employed by an insurer who writes boiler and pressure vessels explosion insurance policies (ENGLE);
- one registered mechanical engineer (ANDERSON);
- one boilermaker (**BEACH**);
- one owner and user (or representative of) of a low pressure boiler (RAPP);

- one owner and user (or representative of) of a pressure vessel, with practical experience with pressure vessels (VACANT);
- one owner or employee of a boiler installation and repair business (DUNN);
- one steamfitter (BAIER);
- one practical steam operating engineer (LAMB);
- one public member, not otherwise eligible for appointment (**GARVEY**); and
- the chief boiler inspector, the board's nonvoting secretary (VACANT).

Members are limited to two full four-year terms.

### **Duties<sup>4</sup>**

The board formulates and promulgates rules for the safe construction, installation, inspection, operation, maintenance, and repair of boilers and pressure vessels. Its duties include:

- adopting rules for, and engaging in, administration, examinations, regulation, and enforcement;
- providing continuing education;
- setting fees; and
- hearing appeals and imposing fines.
