## Composition<sup>3</sup>

The board consists of 13 members, including:

- 11 at-large members, (ANDRIES, JOHNSON, JONES-CENTENO, KRAMER, MORALES, MURPHY, PRICE, SCHALLERT, VAN DYKE, YAMASAKI, VACANT):
- one representative, appointed by the Speaker of the House of Representatives, nonvoting (LIVELY); and
- one senator, appointed by the President of the Senate, nonvoting (HANSELL).

The at-large appointees must reflect Oregon's geographic and cultural diversity and have a commitment to Oregon's culture, as demonstrated by their respective backgrounds.

Members serve four-year terms. The board selects its chair and vice chair; a majority of appointees constitutes a quorum; and the board meets at least once every three months.

The board oversees management of the Trust for Cultural Development Account and provides direction to the Oregon Business Development Department with respect to its administration of the Arts Program and its use of funds. The board is also the custodian of any property received as trustee for the state.
