

#### **WORKGROUP SHARED PRINCIPLES**

- Long-term and durable funding for wildfire response and mitigation should be a priority investment for the state.
- Funding solutions should ensure financial solvency of agencies' wildfire programs.
- Mitigation and response are interdependent functions of the cohesive wildfire strategy, and both need to be adequately funded.
- Funding solutions should: align with response and mitigation costs and reflect shared responsibility and benefits among all Oregonians and visitors to the state.
- Wildfire response and mitigation strategies should consider equitable, affordable and sustainable contributions from payees into the system, including in-kind contributions.
- Funding strategies should aim to maintain high standards of service (meeting missions for protecting life, property and natural resources).

#### **WORKGROUP PROGRESS**

**Alternative funding strategies**—Started with nearly 70 ideas, narrowed down to about 20

#### **Barriers to implementation**

- Financial burden to and equitable contributions from payers
  - Political considerations
- Difficulty of adoption & implementation
- Size of financial contributions
- Avoiding double taxation and more

**Sustainability risks**—One-time infusions vs. ongoing funding







## **THEMES**

- This is a priority, complex topic that needs comprehensive solutions
- Sustainability and affordability are critical
- Agency solvency required
- Modernizing Oregon wildfire funding
- Must be proactive and invest in prevention, community risk reduction, and landscape resilience







### **NEXT STEPS**

- Workgroup continue to refine strategies in January
- Work to gain alignment where possible on strategies and options
- Work with legislators, workgroup, and the executive branch during the 2025 session on strategies
