SUMMARY

Digest: Makes the State Chief Information Officer contract with a third party for a study of how the state uses information and technology and advise on how to improve. Makes the officer submit a report. The Act takes effect on its passage. (Flesch Readability Score: 61.6).

Requires the State Chief Information Officer to contract for an independent assessment of the information technology environment within the executive department, to include recommendations for improving performance, operations and resources.

Directs the officer to submit a report on the results of the assessment and recommendations to the Governor and the Joint Legislative Committee on Information Management and Technology and any other appropriate legislative committee.

Declares an emergency, effective on passage.

 - (b) Identify and describe alternative information technology governance programs and organizational and operational models for consideration to be used by or within the executive department;
- 10 (c) Recommend an information technology governance program and 11 organizational and operational models that may be adopted and used 12 by or within the executive department to improve performance, oper-13 ations and resources;
 - (d) Conduct a gap analysis to compare the current information technology environment with the recommended information technology environment; and
- 17 (e) Provide a plan to implement the recommendations, including
 18 estimated costs and time frames.
- 19 (4) The assessment must be completed no later than ______, 2026.
- (5) The State Chief Information Officer shall submit a report in the 20 manner provided by ORS 192.245, and may include recommendations 21for legislation, to the Governor and to the Joint Legislative Committee 22 on Information Management and Technology and any other appropri-23 ate legislative committee no later than ______, 2026. The report 24 submitted under this subsection shall provide the results of the as-25 sessment and include a budget request to carry out the plan to im-26 plement the recommendations. 27
- 28 SECTION 2. Section 1 of this 2025 Act is repealed on January 2, 2027.
