## SUMMARY

Digest: The Act makes changes to CCO health improvement plans. (Flesch Readability Score: 75.5).

Requires a community health improvement plan to serve as the primary regional planning document for all health services and operations and incorporate various other planning documents.

## A BILL FOR AN ACT

2 Relating to community health improvement plans; creating new provisions;  
3 and amending ORS 414.577.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. ORS 414.577 is added to and made a part of ORS chapter**  
6 **414.**

7 **SECTION 2.** ORS 414.577 is amended to read:

8 414.577. (1) A coordinated care organization shall collaborate with local  
9 public health authorities, **community mental health programs** and hos-  
10 pitals located in areas served by the coordinated care organization to con-  
11 duct a community health assessment and adopt a community health  
12 improvement plan, shared with and endorsed by the coordinated care organ-  
13 ization, local public health authorities, **community mental health pro-**  
14 **grams** and hospitals, to serve as a strategic population health and health  
15 care services plan for the residents of the areas served by the coordinated  
16 care organization, local public health authorities, **community mental**  
17 **health programs** and hospitals. The **community** health improvement plan  
18 must include strategies for achieving shared priorities.

19 **(2) The community health improvement plan shall serve as the**

1 **primary regional planning document for all health services and oper-**  
2 **ations and shall incorporate:**

3 **(a) Plans to address:**

4 **(A) Health inequities;**

5 **(B) Social determinants of health;**

6 **(C) Health technology;**

7 **(D) Payment models;**

8 **(E) Oral health integration;**

9 **(F) Language access;**

10 **(G) Traditional health worker integration and utilization; and**

11 **(H) Mental health parity analysis;**

12 **(b) Local drug and alcohol planning;**

13 **(c) Community diversion plans;**

14 **(d) Local plans adopted by local mental health authorities under**  
15 **ORS 430.630;**

16 **(e) Comprehensive behavioral health planning by coordinated care**  
17 **organizations; and**

18 **(f) Any other health services or operations planning document pre-**  
19 **scribed by the Oregon Health Authority.**

20 [(2)] (3) The coordinated care organization shall post the **community**  
21 health improvement plan to the coordinated care organization's website.

22 [(3)] (4) The [*Oregon Health*] authority may prescribe by rule requirements  
23 for **community** health improvement plans and provide guidance for aligning  
24 the timelines for the development of the community health assessments and  
25 **community** health improvement plans by coordinated care organizations,  
26 local public health authorities, **community mental health programs** and  
27 hospitals.

28 **SECTION 3. Section 2 of this 2025 Act applies to community health**  
29 **improvement plans adopted on or after the effective date of this 2025**  
30 **Act.**
