LC 2002: Separates statutory provisions for possession, delivery, and manufacture of fentanyl from provisions applicable to general controlled substance offenses. Adds fentanyl to specified statutes creating mandatory sentences for manufacture and delivery of controlled substances. Expands the definition of “local correctional facility” for the Oregon Jail-Based Medications for Opioid Use Disorder Grant Program to include facilities operated by a county supervisory authority. Clarifies conditions under which a pharmacist may prescribe, administer, and dispense medications for the treatment of opioid use disorder. Clarifies permissible operation of a prescription drug locker by retail drug outlets. Modifies permissible conditional discharge conditions for unlawful possession of a controlled substance offenses. (Dated 11/27/24).

LC 3200: Requires the Oregon Health Authority to study changes to law regarding opioid use disorder medication and submit a report to the Legislative Assembly by September 15, 2026. (Dated 10/10/24).

LC 3216: Requires the Oregon Judicial Department to study ways to improve the process for setting aside convictions for drug enforcement misdemeanors and submit a report to the Legislative Assembly by September 15, 2026. (Dated 11/27/24).

LC 3243: Directs the Alcohol and Drug Policy Commission (ADPC), in collaboration with the System of Care Advisory Council (SOCAC), the Oregon Health Authority (OHA), and the Oregon Department of Education (ODE) to conduct a study to assess the feasibility of increasing the services of school-based substance use prevention, screening, intervention, and referral programs. Requires ADPC to submit a report on the study to the Legislative Assembly by September 15, 2026. Requires ADPC, in collaboration with SOCAC, to develop a

comprehensive plan for a youth continuum of care to prevent, treat, and provide substance use disorder (SUD) recovery services. Requires OHA, in partnership with ODE and ADPC, to provide grants to approved recovery schools for specified purposes related to youth SUD treatment capacity. Requires ADPC, in partnership with OHA, to establish a multimedia public education and awareness campaign regarding youth SUD resources and education opportunities. Declares emergency, effective on passage. (Dated 12/3/24).

LC 3253: Requires the Oregon Criminal Justice Commission to study how different dispositional outcomes for drug enforcement misdemeanor charges affects rates of recidivism and submit a report to the Legislative Assembly by September 15, 2026. (Dated 11/27/24).

LC 3269: Requires the Oregon Criminal Justice Commission to study recidivism rates for persons convicted of drug enforcement misdemeanors and submit a report to the Legislative assembly by September 15, 2026. (Dated 11/27/24).

LC 3385: Directs the Oregon Criminal Justice Commission to study the Oregon Behavioral Health Deflection program and provide results to the Legislative Assembly by May 1, 2026. (Dated 10/29/24).

LC 3392: Directs the Alcohol and Drug Policy Commission (ADPC), in collaboration with the Oregon Health Authority (OHA), to develop statewide policies and practices to support broad availability to medications for opioid use disorder (MOUD) and report to the Legislative Assembly by September 30, 2026. Directs ADPC to assess current programs and funding to support patient referral from emergency departments to low-barrier community substance use disorder clinics and report to the Legislative Assembly by September 30, 2026. Requires OHA to develop an enhanced funding model to support low-barrier community substance use disorder clinics accepting referrals from emergency departments to treat referred individuals with MOUD. Repeals prohibition against operating a methadone clinic within 1,000 feet of a school or licensed child care facility. Declares emergency, effective on passage. (Dated 11/27/24).

LC 3421: Directs the Alcohol and Drug Policy Commission, in collaboration with the System of Care Advisory Council, to study needed treatment and recovery services for youth with co-occurring diagnoses and the barrier to accessing and receiving holistic services and report to the Legislative Assembly by September 15, 2026. Declares emergency, effective on passage. (Dated 11/27/24).
