Courts and the OSB – Justice Partners

- Courts have inherent and statutory authority to regulate the practice of law
- The Oregon State Bar is an instrumentality in the Judicial Branch and performs that regulatory activity, subject to oversight by the Supreme Court
- Shared mission to promote and provide a fair and accessible justice system
- Too many without access to legal representation = Justice Gap

- Taxpayers are self-represented in 30% of cases in Magistrate Division
- Extensive FAQ document and six videos to help taxpayers understand processes








Child Support

- Establishes financial responsibility and payment plans for non-custodial parents
- Legislature helped create remote child support docket in 2023
 - Operates in eight counties
 - 1,805 cases heard since April 2023
 - Hearings held by phone or video
 - Appearance rate is 12% higher than in-person hearings
 - 75% compliance with payments

Family Law



- 43,000 cases per year
 - Almost 45% are protective orders, others include divorce and child custody issues
 - More than 86% of family law cases have at least one unrepresented party
 - Courts rely on facilitators and forms to help









Evictions





Consumer Debt

99% of debtors self-represented; 96% do not even appear; 69% of cases end in a default judgment

Fee

The court may charge a fee for turning in certain forms to the court (the courts call this 'filing'). The fees are the same in every circuit court in Oregon. Visit the court fees page and click on "Circuit Court Fees" for more information. Protection order cases never have filing fees.

Can't afford to pay? You can ask the court to waive your fee (file for free) or defer your fee (pay later). Find the fee waiver/deferral application here.



Learn about Oregon Law

- Oregon Law Help: free legal information plus help finding free and low-cost lawyers and legal help.
- Rules Center: rules for Oregon circuit
 courts
- Oregon Revised Statutes (ORS): state laws created by the Oregon Legislature
- Oregon Rules of Civil Procedure: rules about filing a civil case or taking it to court in Oregon. Family law and landlord-tenant law cases are both "civil cases."

Court Facilitators

- Authorized by judge, do not practice law
- In-person or remote services
- Help fill out forms, understand court processes, refer to resources
- Reduce errors that judge needs to address during hearing

Legal Information vs. Legal Advice

Legal Information (OK)

- How to find forms and how to complete them
- How court procedures and rules work
- How to begin a court action
- Referrals to agencies or resources that provide legal and other services
- Reviewing documents and forms to make sure they are complete

Legal Advice (Not OK)

- Offering an opinion about a possible outcome of an action
- Advising or recommending someone take a particular course of action
- Recommending specific forms for solving a specific legal problem
- Telling someone they should or should not sue, file a complaint, or take other legal action
- Recommending one procedure or type of pleading over another

Guide & File: Interactive Online Forms

Oregon circuit courts provide online forms (sometimes called iForms) for self-represented court users to electronically complete forms and file or respond to cases. Guide & File is an online program that works on any computer or mobile device.




Using Guide & File is FREE. The only cost is the required filing fee when you turn in the form to the court. Note: Restraining orders never require a fee. <u>Learn more about filing fees</u>.

Guide & File is only available for these types of cases:

- Protection orders (restraining orders, elder abuse, sexual abuse, stalking)
- · Divorce, separation, or custody cases
- Changing a family judgment (modification)
- Developing a parenting plan
- · Application for a court-appointed lawyer (criminal cases only)
- Residential evictions
- Small claims complaints
- Name or legal sex change
- Motion to seal your eviction, marijuana, or criminal record (expungement)
- Satisfaction of a money award (when you have received payment on a court judgment in your favor)
- Firearms surrender declaration (responding to a court order to give up your firearms)

Legal Resource Centers

- Full-time, operated by courts
- Have family & civil case facilitators
- Have legal resources
- Not available statewide
- Access to reference services and legal databases through the State of Oregon Law Library

Getting Feedback & Community Engagement

- Access and Fairness Survey

2025 Legislative Issues

- OJD Bills (Senate)
 - LC 461. Reporting and fee increases to support local mediation/conciliation services
 - LC 456. Adds judicial positions in high-need counties
- Priority Budget Requests
 - POP 103-106. Additional court staff to maintain customer services in family law, protective order, landlord-tenant, and other case types with growing filings and needs
 - POP 108. Funds the positions requested in LC 456
