156	11/21/2024	Updates, reorganizes and modifies the provisions governing appeals from municipal and justice courts that have not become courts of record. Establishes procedural statutes for municipal court appeals that are separate from justice court provisions. Requested by the Oregon Law Commission
513	7/19/2024	Changes notice requirements and requirements related to facilities and technology for motions to allow remote location testimony. Requested by the Oregon State Bar.
514	7/17/2024	Revises some of the time limits allowed for filing complaints with the Construction Contractors Board. Requested by the Oregon State Bar.
515	7/15/2024	Clarifies the total amount or value of a claim required to request a jury trial in small claims court, to include prejudgment or preaward interest, fees and costs. Requested by the Oregon State Bar.
785	9/27/2024	Makes non-substantive and technical changes in Oregon law. Corrects grammar and punctuation. Conforms language to existing statutes and legislative style. Requested by Legislative Counsel.

834	10/29/2024	Provides that the unlawful departure of a person from the custody of a parole and probation officer constitutes the crime of escape. Submitted at the request of Authorizes parole and probation officers to view digital copies of driver license photographs retained by the Department of Transportation. Requested by the Federation of Oregon Parole and Probation Officers.
1372	10/11/2024	The Act makes changes to what a court can order with regard to the parties' property rights while a case to end the marriage is pending.
1107	10/2/2024	Allows a law enforcement agency or public body to provide information, or enter into an agreement to provide information, as required to affect an international extradition, and return of a person charged with or convicted of a crime in this state and for whom a warrant of arrest has been issued. Prohibits a law enforcement agency or public body from entering into an agreement to provide information about an individual in custody to a federal immigration authority. Provides for exceptions. Requested by the Oregon District Attorneys Association.
1448	10/29/2024	Defines "dangerous to self," "dangerous to others" and "serious physical harm" for the purpose of involuntarily committing a person with mental illness. Describes evidence that the court may consider in civil commitment proceedings. Requested by the National Alliance on Mental Illness
2320	11/20/2024	Provides that a district attorney may require the payment of a fee reasonably calculated to reimburse costs before providing discovery to a defendant. Requested by the Association of Oregon Counties.
2324	12/2/2024	Establishes a time limit on when a district attorney may submit an indictment to the grand jury on a pending case when a trial date has been scheduled. Authorizes the use of grand jury recordings to challenge the indorsement of an indictment "a true bill." Requires the district attorney to file a motion for admission of evidence seized pursuant to a warrantless search. Authorizes the court to modify the release decision after ordering preventative pretrial detention if circumstances have changed. Authorizes the court to enter a judgment for a Class A violation when a person is convicted of a misdemeanor. Requested by the Oregon Criminal Defense Lawyers Association.

2362	12/3/2024	Directs the Oregon Health Authority to expand the capacity of the Oregon State Hospital. Requires certain updates and reports when a defendant has been ordered to engage in community restoration services due to lacking fitness to proceed. Authorizes the release of the defendant's fitness to proceed records upon request in specified circumstances. Authorizes the court to order the defendant to participate in an in-custody jail-based restoration treatment program when the defendant lacks fitness to proceed. Authorizes the Oregon Public Guardian and Conservator to establish a program for persons found to lack fitness to proceed and to receive records concerning the defendant. Modifies the criteria for the commitment of an extremely dangerous person with mental illness. Requested by the Oregon District Attorneys Association.
2372	10/21/2024	Modifies when a person is guilty except for insanity. Requested by the Oregon District Attorneys Association.
2614	11/11/2024	Shifts the burden of proof to the state during hearings on the issue of sex offender reporting by juvenile offenders. Requested by the Oregon Criminal Defense Lawyers Association.
2631	12/2/2024	Modifies the requirements for providing a declaration for the purposes of authenticating records in response to criminal process. Authorizes a law enforcement agency to use forensic imaging to obtain information from a portable electronic device belonging to a deceased user if the death is the subject of a law enforcement investigation. Provides that a warrant authorizing the installation or tracking of a mobile tracking device may be issued when an individual has committed a crime. Authorizes a prosecuting attorney to turn over grand jury recordings to the defense attorney as soon as a decision not to file a motion for a protective order has been made. Provides that a person released pretrial on a violent felony who violates a condition of release may be held in custody if the violation constitutes a new criminal offense. Submitted at the request of the Oregon District Attorneys Association.
2648	11/12/2024	Crime level changes for certain crimes, when victims are under 18 years of age. Requested by the Oregon District Attorneys Association.
3384	10/21/2024	Modifies the court's authority regarding the parties' property rights while a proceeding to terminate a marriage is pending. Requested by Representative Wallan.

3538	11/8/2024	Modifies the process for setting aside convictions, dismissals, contempt of court findings and guilty except for insanity judgments. Increases the waiting period for setting aside certain types of contempt of court findings. Modifies when the court is required to hold a hearing on and grant motions to set aside. Requires that the court enter an order within 120 days of granting a motion to set aside. Specifies a process for when a person has outstanding financial obligations and authorizes the court to waive such obligations under specified circumstances. Provides that the required time period prior to filing the motion, during which the person is required to have no convictions, applies to motions to set aside convictions and certain arrests, charges, and citations only. Provides that the dismissal of a traffic violation citation may not be set aside. Requested by Rep. Tran and Chair Kropf.
3676	12/2/2024	Repeals a manner of committing the crime of harassment. Requires that for a manner of committing the crime of aggravated harassment, the person must create a risk of spreading communicable disease to the victim. Reduces to Class A violation offenses the crimes of failure to appear in a violation proceeding, failure to appear in the second degree, criminal trespass in the second degree, criminal mischief in the third degree, failure to carry a license or to present a license to a police officer and, under specified circumstances, failure to appear on a criminal citation, theft in the third degree, failure to report as a sex offender, driving while suspended and failure to perform the duties of a driver when property is damaged. Punishes by a maximum fine of \$2,000. Requested by the Oregon Criminal Defense Lawyers Association.
3677	11/1/2024	Modifies when a prior conviction is admissible to impeach the character of a witness. Limits prior convictions that may be used to calculate the criminal history of a defendant for the purposes of sentencing. Requested by the Oregon Criminal Defense Lawyers Association.
