43	10/21/2024	Placeholder bill for the Uniform Parentage Act workgroup product.
266	11/18/2024	Updates and modernizes laws that govern the formation, governance, operations and conversion of limited liability companies in this state and relations among members, managers and third parties with respect to limited liability companies in this state.
291	8/20/2024	Amends the requirements for the State Land Board to assert title to historically filled lands. Repeals the provisions related to assertion of title to historically filled lands by the State Land Board that are required to be completed before December 31, 2025.
511	10/30/2024	Changes the term "member" of the Oregon State Bar to the term "licensee."
516	8/15/2024	Amends portions of the UCC to govern use of digital assets, electronic money, chattel paper, and hybrid transactions, and makes other updates to the code and related statute.

517	10/8/2024	Modifies evidence required to establish parentage in a probate proceeding. Exempts certain bequests from asset limits for simple estates. Restricts application of harmless error provisions to nonelectronic writings signed by the decedent or at the decedent's direction. Modifies court procedures regarding discovery when there is a contested issue in a probate proceeding.
1108	11/5/2024	Requires the Department of State Police to study forensic science. Directs the department to submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026. Sunsets on January 2, 2027.
1116	11/5/2024	Requires the Oregon Criminal Justice Commission to study workplace assault convictions and sentences. Directs the commission to submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.
1446	10/29/2024	Defines "dangerous to self," "dangerous to others" and "serious physical harm" for the purpose of involuntarily committing a person with mental illness. Describes evidence that the court may consider in civil commitment proceedings.
1699	11/12/24	Authorizes the destruction of hoop houses when executing a search warrant to investigate the unlawful production of marijuana. Requires the Oregon Liquor and Cannabis Commission to make the map of licensed industrial hemp operations and marijuana production premises available to the Water Resources Department and the Department of Environmental Quality. Repeals the prohibition on a marijuana retailer locating within 1,000 feet of a building where a public prekindergarten or kindergarten program is provided. Allows the State Department of Agriculture to inspect biomass and processed industrial hemp stored at the location of a licensed industrial hemp operation.

1727	12/04/2024	Makes violations of prohibitions against certain practices with respect to insurance is subject to an enforcement action under the Unlawful Trade Practices Act. Allows appropriate equitable relief in addition to monetary damages. Requires the Director of the Department of Consumer and Business Services to request action before a prosecuting attorney may take action under the Unlawful Trade Practices Act against an act or practice related to insurance.
2031	11/15/2024	Removes OHA registration requirements for a medical marijuana cardholder's production of marijuana for personal medical. Requires a grower that produces marijuana for medical use for three or more medical cardholders to apply for a designation from the OLCC. Directs the OHA to issue electronic medical registration cards. Requires a marijuana retailer to offer for sale medical grade cannabinoid items that contain not more than 20 percent total THC. Creates health care and employment protections for a person who is a registry identification cardholder.
2123	12/2/2024	Modifies discovery procedures. Establishes timing requirements for discovery provided to the defense, including jail calls and evidence supporting a request to hold a defendant in custody pretrial. Requires the court to hold a colloquy before trial or plea to ensure that all exculpatory material has been provided to the defense. Establishes procedures by which a deposition of a law enforcement officer may occur.
2317	11/20/2024	Provides that a district attorney may require the payment of a fee reasonably calculated to reimburse costs before providing discovery to a defendant.
2367	10/11/2024	Makes permanent changes to the laws that shield landowners from lawsuits arising from recreational use of the land.

2708	11/18/2024	Limits a plaintiff from suing a person for defamation if arising out of a disclosure of sexual assault, harassment or discrimination, and the person had a reasonable belief that it happened when making the disclosure.
3154	10/14/2024	Allows for the sharing of data as needed to affect an extradition for a crime of a person from outside of this country to this state.
