# Composition<sup>3</sup>

The commission consists of 11 members, including

- at-large members (HEPPER, PREUS, REXFORD, SCOTT-SCHWALBACH, SWANDER, VACANT, VACANT); and
- no more than five school district employees (DANZUKA, MOONEY, TOWNSEND, VAZQUEZ CANO).

Members serve four-year terms. The Governor selects the chair and vice chair. The commission meets at the call of the chair or of a majority of commission members.

#### **Duties**

The Oregon Educational Act for the 21<sup>st</sup> Century established quality education goals for the state's K-12 public schools.<sup>4</sup> The commission determines the amount of funding needed to meet those goals.<sup>5</sup> The commission must<sup>6</sup>

- each biennium, determine the amount of moneys sufficient to ensure that the state's system of K-12 public education meets the quality goals;
- identify best practices based on research, data, professional judgment, and public values that lead to high student performance and the costs of implementing those best practices in the state's K-12 public schools; and
- each biennium, issue a report to the Governor and the Legislative Assembly that identifies
  - o current practices in the state's system of K-12 public education,
  - o the costs of continuing those practices,
  - o the expected student performance under those practices, as well as
  - the best practices for meeting the quality goals,
  - the costs of implementing the best practices,
  - o the expected student performance under the best practices; and
  - at least two alternatives for meeting the quality goals.
