## **Public Hearing**

HB 2610 \*\* \*\*Subsequent Referral(s) to Ways and Means

Directs Oregon State University to research reduced-risk pest management tools for Oregon's specialty crops and report to interim committees of Legislative Assembly no later than September 15, 2027.

HB 2813 \*\*

\*\*Subsequent Referral(s) to Ways and Means Requires Oregon Health Authority to ensure that communities in this state have access to safe drinking water.

HB 3097

> Provides that municipal corporation or people's utility district may apply for certificate to use water for hydroelectric purposes within artificial delivery system even if municipal corporation or people's utility district is not holder of underlying water right, with permission of holder of underlying water right.

## HB 3098

Directs State Department of Agriculture, in consultation with Pesticide Analytical and Response Center, to establish farmworker outreach program.
