HB 2813 **

**Subsequent Referral(s) to Ways and Means Requires Oregon Health Authority to ensure that communities in this state have access to safe drinking water.

2903 ** HB

**Subsequent Referral(s) to Ways and Means

Requires State Department of Fish and Wildlife, State Fish and Wildlife Commission and Department of State Lands to implement Ocean Policy Advisory Council recommendations to develop adaptive management and social monitoring program to support marine reserves.

HB 3097

Provides that municipal corporation or people's utility district may apply for certificate to use water for hydroelectric purposes within artificial delivery system even if municipal corporation or people's utility district is not holder of underlying water right, with permission of holder of underlying water right.

HB 3130 **

**Subsequent Referral(s) to Ways and Means Appropriates moneys to Water Resources Department to fund staff position, or contract for

services, related to voluntary agreements among ground water users from same reservoir.

Public Hearing

HB 3164

Makes permanent provisions conditionally allowing water right lease to split use of water between existing water right and in-stream water right within same year.

HB 3222

Appropriates moneys from General Fund to Oregon Department of Administrative Services for distribution to High Desert Partnership for specified purposes.

2238 HB

Authorizes Director of Department of State Lands to adopt rules establishing fees related to removal or fill permit applications, wetland delineation reports and general authorizations.

HB 3163

Establishes Place-Based Water Planning Fund.
