Public Hearing and Work Session

HB 2206

Requires Department of State Lands to study creation of credits for restoration of salmon habitat.

HB 3021

Establishes that perfected and developed water right is not subject to forfeiture if owner of water right ceased to use all or part of water appropriated for period of five successive years because owner engaged in water conservation practices or distribution of water that owner received from water district was less than certificated maximum for period of at least five successive years.

HB 2765

Grants to South Suburban Sanitary District exclusive right to use and sell treated wastewater discharged by district into Klamath River or tributaries.

HB 2127

Requires Department of Land Conservation and Development to study changes to Land Conservation and Development Commission and abolishment of Land Use Board of Appeals.

HB 2659

Requires Land Conservation and Development Commission to update rules adopted in response to Governor's executive order on climate to address specific issues.

HB 3191 **

**Subsequent Referral(s) to Housing and Homelessness

Allows city to expand its urban growth boundary, or to require Metro to expand its urban growth boundary, in order to include land designated as urban reserve that supports workforce housing and commercial development supportive of workforce housing if certain conditions are met.

HB 3343

Requires Water Resources Department to study sustainable management of ground water.

HB 3475

Requires State Department of Fish and Wildlife to study animal sanctuaries.

HB 3292 **

**Subsequent Referral(s) to Ways and Means

Directs State Department of Agriculture to establish grant program for purpose of facilitating eradication of gorse for wildfire mitigation in southwest Oregon.

- HB 2899
Removes certain lands from definitions of buildable lands for purposes of urbanization.
- HB 3365
Authorizes certain Deschutes Basin irrigation districts to temporarily allow change of place of use of water, or change in point of diversion, within Deschutes Basin irrigation districts.
- HB 3362
Allows city or county to validate unit of land that had been approved for creation or recognition that was later revoked after sale to innocent purchaser.
- HB 3440
Allows counties with population between 200,000 and 650,000 to elect to distribute receipts from sales of certain lands and mineral rights through alternative mechanism.
- HB 3479
Requires Water Resources Department to study budget of department.
- HB 3480
Requires Oregon Watershed Enhancement Board to study budget of board.
- HB 3052
Requires Department of State Lands to study natural resources in Oregon.
- HJR 23 ** **Subsequent Referral(s) to Rules
Proposes amendment to Oregon Constitution to modify return of surplus revenue to personal income taxpayers by directing percentage of surplus revenue to reserve fund established to combat drought.
- HB 3468 ** **Subsequent Referral(s) to Revenue
Provides for portion of surplus revenue refunds to be directed to Oregon Drought Reserve Fund instead of returned to personal income taxpayers.
- HB 3570
Requires State Department of Fish and Wildlife to allow person meeting certain criteria to hunt game mammals using crossbow.

Work Session

- HB 2192
Aligns criteria for alteration, restoration or replacement of a dwellings on lands zoned for forest use consistent with criteria applicable to dwellings on lands zoned for farm use.
- HB 2253
Disqualifies land from farm use special assessments upon final civil penalty or judgment of conviction for illegal growing of crops against landowner or person in possession and control of land.
- HB 2487
Allows lands zoned for exclusive farm use to be used for weddings or events east of the summit of the Cascade Range.
- HB 2929
Authorizes Water Resources Department to seek injunctive relief if person has engaged, or is about to engage, in activity that is or will be violation of certain water laws.
- HB 3159 ** **Subsequent Referral(s) to Revenue
Increases state transient lodging tax.
- HB 3181
Directs State Department of Energy and Department of Land Conservation and Development to convene work group to examine barriers, opportunities and other issues related to renewable energy and transmission project siting in Oregon.

HB 3207

Amends reporting requirements for real estate transaction sampling of domestic wells to require labs conducting tests to submit results to Department of Environmental Quality.

HB 3458

Limits issues that may be basis for appeal of land use decisions where local government amends comprehensive plan or land use regulations.

HB 3580

Authorizes holders of certain water rights in Upper Klamath Basin to relocate points of diversion to consolidated point of diversion under certain circumstances.
