SB 872 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Instructs State Forestry Department to endeavor to partner with federal agencies to undertake certain activities in federal forests related to fire prevention and request that federal agencies fund portions of activities.

SB 886 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Removes requirement that State Department of Fish and Wildlife obtain confidentiality agreement when disclosing certain animal data to federal government, tribal government, public body, public utility or college or university.

SB 718 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Provides that year in which Governor declares that drought exists, or is likely to exist, within county does not count toward period of time for forfeiture of water right for nonuse for holder of water right within county.

SB 507 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Makes certain changes to farm direct marketing law.

SB 789

Makes permanent certain restrictions on growing canola within Willamette Valley Protected District.
