- HB 2539 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from General Fund to Oregon Department of Administrative Services for distribution to Trillium Family Services for construction of facility for Oregon Center for Child, Family and Community Health.
- HB 3126 ** **Subsequent Referral(s) to Ways and Means
Establishes Emergency Behavioral Health Services for Children program in Oregon Health Authority to promote timely delivery of behavioral health services to children who present to hospital emergency departments in behavioral health crises.
- HB 2455
Imposes requirements and restrictions on insurer and coordinated care organization audits of claims for reimbursement submitted by behavioral health treatment providers.

- HB 2773 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 3-13-2023 MEETING: Requires Oregon Health Authority to provide incentives to increase recruitment and retention of local public health professionals.
- HB 2925
CARRIED OVER FROM THE 3-13-2023 MEETING: Extends deadlines for affinity group task forces to complete their work with respect to allocations of resources to address communities' needs and health inequities faced by communities and to report recommendations to Legislative Assembly.
