HB 3157 \*\* \*\*Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 3/27/2023 MEETING: Establishes Health Insurance Mandate Review Advisory Committee to review each proposed legislative measure, legislative concept or amendment that requires health insurer or health care service contractor to reimburse cost of specified procedure or provider, if measure, concept or amendment is posted to legislative committee's agenda, and to produce report on equity and financial effects of each required coverage that is proposed and efficacy of treatment or service proposed. ## **REVISED -- AWAITING APPROVAL (CONT.) April 3, 2023**

### HB 3258

Requires monitoring and reporting by prescription drug program prescription and dispensation of prescription drugs classified in schedule V of federal Controlled Substances Act.

HB 2642

Requires practitioner to query electronic prescription monitoring system with respect to patient prior to issuing to, or renewing for, patient prescription for certain prescription drugs.

HB 2513

Requires Oregon Health Authority to study implementation of Ballot Measure 110 (2021). HB 2045

Requires Oregon Health Authority to study access to health care in Oregon.

### HB 2697

Requires hospitals to establish technical staff and service staff staffing committees to develop staffing plans, in addition to nurse staffing committee.

HB 2742

Excludes certain costs from consideration as total health expenditures for purposes of Health Care Cost Growth Target program.

HB 2926 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Oregon Health Authority to establish program to provide financial incentives to hospitals for offering clinical training opportunities for nursing students.

HB 3324 \*\*

\*\*Subsequent Referral(s) to Ways and Means Directs Oregon Health Authority to establish program to provide incentives to nurse instructors. HB 2928 \*\* \*\*Subsequent Referral(s) to Ways and Means

Extends health care provider incentive program to health care providers who are students enrolled in health professional training programs leading to licensure as licensed practical nurse or registered nurse.

HB 3596

Allows person to practice surgical technology at health care facility if person has completed and is certified by specified apprenticeship program.

HB 2421

> Allows applied behavior analysis professional to provide outpatient treatment for mental or emotional disorder or chemical dependency to certain patients without parental consent.

HB 2736

Enacts interstate Occupational Therapy Licensure Compact.

HB 2002 \*\*

Modifies provisions relating to reproductive health rights.

HB 2235

Requires Oregon Health Authority to study access to behavioral health treatment in rural and medically underserved areas of this state.

HB 2977 \*\*

\*\*Subsequent Referral(s) to Ways and Means Requires Higher Education Coordinating Commission, in collaboration with Oregon Health Authority, to establish grant program for purpose of distributing moneys to institutions of higher education to develop programs that prepare students to enter into behavioral health workforce.

#### HB 2651 \*\*

Appropriates moneys from General Fund to Oregon Health Authority to be used for specified purposes related to expanding behavioral health provider workforce.

## **REVISED -- AWAITING APPROVAL (CONT.) April 3, 2023**

### HB 3090

Prohibits distributing, selling, attempting to sell or allowing to be sold flavored inhalant delivery system product or flavored tobacco product in this state.

HB 3320

Imposes new requirements on hospitals with respect to financial assistance policies and processes.

HB 2878 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Aligning for Health Pilot Program, administered by Oregon Health Authority, to test alternative methods for payment for health care.

HB 2445

CARRIED OVER FROM THE 3/28/2023 MEETING: Authorizes independent behavioral health certification entity that meets specified requirements to certify addiction peer support specialists to work with coordinated care organizations.

HB 2455

CARRIED OVER FROM THE 3/28/2023 MEETING: Imposes requirements and restrictions on insurer and coordinated care organization audits of claims for reimbursement submitted by behavioral health treatment providers.

### HB 2817

CARRIED OVER FROM THE 3/29/2023 MEETING: Clarifies area of leg to which definition of "podiatry" applies.

### HB 2927 \*\*

CARRIED OVER FROM THE 3/29/2023 MEETING: Establishes Statewide Steering Committee on Sickle Cell Disease.

HB 3126 \*\*

\*\*Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 3/29/2023 MEETING: Establishes Emergency Behavioral Health Services for Children program in Oregon Health Authority to promote timely delivery of behavioral health services to children who present to hospital emergency departments in behavioral health crises.
