HB 3157 ** CARRIED OVER FROM THE 3/27/2023 MEETING: Establishes Health Insurance Mandate Review Advisory Committee to review each proposed legislative measure, legislative concept or amendment that requires health insurer or health care service contractor to reimburse cost of specified procedure or provider, if measure, concept or amendment is posted to legislative committee's agenda, and to produce report on equity and financial effects of each required coverage that is proposed and efficacy of treatment or service proposed.

HB 3298 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Health Authority to disburse to Oregon Health and Science University funds to support entity established within Oregon Health and Science University that advocates for improved maternal and neonatal outcomes.

HB 3258

Requires monitoring and reporting by prescription drug program prescription and dispensation of prescription drugs classified in schedule V of federal Controlled Substances Act.

HB 2642

> Requires practitioner to query electronic prescription monitoring system with respect to patient prior to issuing to, or renewing for, patient prescription for certain prescription drugs.

HB 2513

Requires Oregon Health Authority to study implementation of Ballot Measure 110 (2021). HB 2045

Requires Oregon Health Authority to study access to health care in Oregon.

HB 3090

Prohibits distributing, selling, attempting to sell or allowing to be sold flavored inhalant delivery system product or flavored tobacco product in this state.

HB 3320

Imposes new requirements on hospitals with respect to financial assistance policies and processes.

HB 2878 **

**Subsequent Referral(s) to Ways and Means

Establishes Aligning for Health Pilot Program, administered by Oregon Health Authority, to test alternative methods for payment for health care.

HB 2445

CARRIED OVER FROM THE 3/28/2023 MEETING: Authorizes independent behavioral health certification entity that meets specified requirements to certify addiction peer support specialists to work with coordinated care organizations.

HB 2455

CARRIED OVER FROM THE 3/28/2023 MEETING: Imposes requirements and restrictions on insurer and coordinated care organization audits of claims for reimbursement submitted by behavioral health treatment providers.

HB 3126 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 3/29/2023 MEETING: Establishes Emergency Behavioral Health
Services for Children program in Oregon Health Authority to promote timely delivery of
