HB 2985 **

**Subsequent Referral(s) to Ways and Means

Directs Department of Consumer and Business Services to establish Prescribed Fire Liability Pilot Program and administer program or authorize Oregon Insurance Guaranty Association to administer program.

HB 2986 **

Directs State Forestry Department to establish by rule Prescribed Fire Capacity Grant Program.

HB 3220

Modifies provisions of electronics recycling program.

HB 3152

Permits Public Utility Commission to institute one or more proceedings to ensure commission's regulations, rules and orders, and programs overseen by commission, align with greenhouse gas emissions reduction requirements and targets established by statute or executive order, do not impede or delay timely and equitable implementation of greenhouse gas emissions reduction requirements and targets, and mitigate energy burden and risks of stranded assets for residential utility customers.

HB 3418 **

**Subsequent Referral(s) to Tax Expenditures

Extends to January 2, 2029, sunset of program for provision of rebate for construction or installation of solar electric system or paired solar and storage system, for residential customer
