#### Work Session

- SB 543 A  
Prohibits food vendor from using polystyrene foam container in sales of prepared food.
- SB 644 A  
Amends requirements relating to wildfire hazard mitigation for development of accessory dwelling units on lands zoned for rural residential use.

#### Public Hearing

- SB 123 A  
Directs producer responsibility organization to consider and develop recommendations for use of digital labeling to convey information about recyclability claims and include recommendations in producer responsibility program plan or plan amendment no later than December 31, 2027.
- SB 1012 A  
Authorizes county to allow homestead rebuilt by same owner on same lot to replace homestead destroyed by September 2020 wildfires to have specially assessed value equal to destroyed homestead's real market value for 2020-2021 property tax year, to extent of square footage of destroyed homestead.
