Requires Oregon Liquor and Cannabis Commission to study alcohol.

#### Work Session

- HB 3431 \*\* \*\*Subsequent Referral(s) to Revenue  
Provides permanent revenue stream from Oregon Marijuana Account to fund Economic Equity Investment Program created under chapter 103, Oregon Laws 2022 (Enrolled Senate Bill 1579).
- HB 3308  
Authorizes Oregon Liquor and Cannabis Commission to issue delivery permit to qualified applicant to deliver alcoholic beverages to final consumers.
- HB 3449  
Requires Oregon Liquor and Cannabis Commission to study alcohol delivery.
- HB 3250 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes Task Force on the State of Sports in Oregon to make recommendations for growing businesses in athletics, team sports, outdoor activities and recreation ecosystem in order to establish Oregon as most conducive location in North America for sports economy.
- HB 3251 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires Oregon Tourism Commission to establish and administer grant program to promote, develop and sustain opportunities for agricultural tourism in rural communities in this state.
- HB 3317  
Establishes Wallowa Rural and Recreational Economic Development Board.
