*HB 3254 is scheduled solely for the purpose of moving it to the House Committee on Rules.*

#### Work Session

HB 3254

Requires Higher Education Coordinating Commission to establish statewide semiconductor industry consortium for purpose of building robust, strategic partnerships between semiconductor industry, institutions of education, workforce organizations and community-based organizations.

*HB 2550 is scheduled solely for the purpose of moving it to the Joint Committee on Tax Expenditures.*

HB 2550 \*\*

\*\*Subsequent Referral(s) to Tax Expenditures

Creates income and corporate excise tax credits for investments in facilities used for manufacturing, siting of headquarters or research.

*HB 3286 is scheduled solely for the purpose of moving it to the House Committee on Revenue.*

HB 3286 \*\*

\*\*Subsequent Referral(s) to Tax Expenditures

Extends sunsets of certain programs providing economic incentives.

HB 2013

Requires Oregon Liquor and Cannabis Commission to study alcohol.

HB 2023

Requires Oregon Business Development Department to study sports in Oregon.

HB 2258

Extends sunset of Oregon Industrial Site Readiness Program.

HB 2516

Directs Oregon Liquor and Cannabis Commission to adopt rules to allow certain marijuana producers to sell marijuana items directly to consumer.

HB 3265

Directs Oregon Liquor and Cannabis Commission to conduct study of feasibility of reporting transactions electronically and each quarter, rather than each month.

HB 3272

Permits Secretary of State to share and communicate with approved organizations information about ethnicity, domicile and veteran status of owner or principal of large business that applies for or renews license, permit or registration in this state.

HB 3349

Establishes regional solutions infrastructure director within Regional Solutions Program.

HB 3416 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys to Oregon Business Development Department for distribution to recipients for industrial lands projects.

HB 3431 \*\*

\*\*Subsequent Referral(s) to Revenue

Provides permanent revenue stream from Oregon Marijuana Account to fund Economic Equity Investment Program created under chapter 103, Oregon Laws 2022 (Enrolled Senate Bill 1579).

HB 3532

Allows Arts Program to use up to five percent of value of Trust for Cultural Development Account for certain administrative purposes.

### Public Hearing and Work Session

HB 3308

Authorizes Oregon Liquor and Cannabis Commission to issue delivery permit to qualified applicant to deliver alcoholic beverages to final consumers.
