HB 2495 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Human Services to immediately increase payments to certain adult foster home providers by 50 percent and, by January 1, 2024, restructure payment methodology to increase base rates and to reduce need for exceptional payments.

HB 2599

Waives background check fee for employees and volunteers of certain respite service providers.

HB 2500 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires that mileage reimbursement be paid to home care workers, personal support workers and other direct support professionals who commute more than 15 miles each way to client's residence.
