HB 2804

Requires Department of Human Services to conduct annual assessment of workforce capacity and needs in each division of department and report results to interim committees of Legislative Assembly no later than February 1 each year.

HB 2589 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Department of Human Services to determine staffing levels needed to complete assessments within 20 days for individuals seeking enrollment in programs for all-inclusive care for elderly, and to submit agency request budget each biennium that reflects resources needed to meet determined staffing levels.
