#### **Work Session**

HB 2468

Requires landlord to allow dwelling to be used as family child care home.

HB 2495 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Human Services to immediately increase payments to certain adult foster home providers by 50 percent and, by January 1, 2024, restructure payment methodology to increase base rates and to reduce need for exceptional payments.

HB 2872 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Early Learning and Care to develop, implement and administer Oregon Imagination Library Project to improve reading proficiency and high school graduation rates by providing enrolled children with one age-appropriate book per child each month.

HB 3235 \*\*

\*\*Subsequent Referral(s) to Tax Expenditures

Creates refundable child tax credit, calculated based on number of dependents of taxpayer under age of 18.

HB 2589 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 3-27-2023 MEETING: Requires Department of Human Services to determine staffing levels needed to complete assessments within 20 days for individuals seeking enrollment in programs for all-inclusive care for elderly, and to submit agency request budget each biennium that reflects resources needed to meet determined staffing levels.

HB 3234

CARRIED OVER FROM THE 3-27-2023 MEETING: Prohibits commitment of children with intellectual disabilities without consent of parent or legal guardian.

HB 3303

CARRIED OVER FROM THE 3-27-2023 MEETING: Establishes Community Information Exchange Board and specifies membership and duties.

HB 3435

CARRIED OVER FROM THE 3-27-2023 MEETING: Renames "Oregon prekindergarten program" to "Oregon Prenatal to Kindergarten Program" to reflect changes in purpose of program.

HB 3558

CARRIED OVER FROM THE 3-27-2023 MEETING: Modifies definitions related to child care for purposes of implementation and enforcement.

HB 3333

Permits Department of Human Services to require specified providers to submit corrective action plan in lieu of investigating report of suspected abuse of child in care in certain circumstances.

HB 2991 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 3-27-2023 MEETING: Directs Department of Early Learning and Care to commission independent study regarding barriers to attaining high quality early childhood workforce.

HB 2957 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 3-27-2023 MEETING: Directs Department of Human Services to establish program to distribute funds to community-based organizations to provide financial assistance to Deferred Action for Childhood Arrivals status recipients for specified purposes.

### Possible Reconsideration and Work Session

HB 2717

CARRIED OVER FROM THE 3-27-2023 MEETING: Establishes oversight of outdoor preschool programs by Office of Child Care.

HB 2504

CARRIED OVER FROM THE 3-27-2023 MEETING: Directs Early Learning Council, in consultation with Office of Child Care and Oregon Center for Career Development in Childhood Care and Education, to adopt rules to address barriers impeding entry into early childhood workforce by international early childhood professionals.
