#### Work Session

- HB 2500 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires that mileage reimbursement be paid to home care workers, personal support workers and other direct support professionals who commute more than 15 miles each way to client's residence.
- HB 2683  
Provides that child who has open case in child welfare system is eligible to participate in Employment Related Day Care subsidy program.
- HB 3176 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires Department of Human Services, in consultation with Office of Immigrant and Refugee Advancement, to award contracts to organizations to provide support services to immigrants and refugees.
- HB 3005 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs Housing and Community Services Department to provide financial assistance to eligible applicants to pay for allowable costs related to early child care infrastructure activities.
- HB 3303  
CARRIED OVER FROM THE 3-29-2023 MEETING: Establishes Community Information Exchange Board and specifies membership and duties.
- HB 2468  
CARRIED OVER FROM THE 3-29-2023 MEETING: Requires landlord to allow dwelling to be used as family child care home.
- HB 2589 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 3-29-2023 MEETING: Requires Department of Human Services to determine staffing levels needed to complete assessments within 20 days for individuals seeking enrollment in programs for all-inclusive care for elderly, and to submit agency request budget each biennium that reflects resources needed to meet determined staffing levels.

Requires Department of Early Learning and Care to study adequacy of early learning in state.

HB 2227

Requires Department of Early Learning and Care to study adequacy of availability of child care in state.

HB 2229

Requires Department of Early Learning and Care to study adequacy of early childhood education in state.
